To the Honorable Speaker and Members of the House of Representatives and the Honorable President and Members of the Senate.

Ladies and Gentlemen:

We, the conferees appointed to confer over the disagreement between the two houses concerning House Bill No. 303 by Representative Gisclair, recommend the following concerning the Engrossed bill:

- 1. That the set of Senate Committee Amendments by the Senate Committee on Transportation, Highways and Public Works (#1501) be rejected.
- 2. That Senate Floor Amendment Nos. 1, 2, and 4 by Senator Gary Smith (#3773) be rejected.
- 3. That Senate Floor Amendment No. 3 by Senator Gary Smith (#3773) be adopted.
- 4. That the following amendment to the Engrossed bill be adopted:

AMENDMENT NO. 1

On page 1, line 2, after "R.S. 32:408(A)(5)(b)(i)" delete the remainder of the line and delete lines 3 through 5 in their entirety and insert the following:

"and to enact R.S. 32:402(C)(6), relative to driver's licenses; to authorize waiver of the skills test for a person regularly employed within the last twelve months in certain military positions; to provide with respect to the operation of a bus during times of emergency by employees of the Department of Transportation and Development; and to provide for related matters."

AMENDMENT NO. 2

On page 1, between lines 8 and 9, insert the following:

§402.	All drivers must secure license; exception; emergency vehicle exception;		
	military personnel exceptions; emergency command post vehicle exception;		
	law enforcement officer exception; Department of Transportation and		
	Development employee exception; violations		
	* * *		

C. * * *

(6) Notwithstanding any provision of this Section or any other law to the contrary, an employee of the Department of Transportation and Development who is operating a bus, in the course and scope of his employment, during a gubernatorially declared state of emergency or disaster shall only be required to possess a Class "E" driver's license.

MTR VEHICLE/DRIVER LIC: Modifies requirements for obtaining a commercial driver's license when an applicant is employed in a specific military position

Report adopts Senate amendments to:

1. Make technical changes.

Report rejects Senate amendments which would have:

- 1. Made technical changes.
- 2. Authorized an operator of a commercial motor vehicle or bus who is employed by the Department of Transportation and Development to operate a commercial vehicle or bus, in the course and scope of employment, during a gubernatorially declared state of emergency or disaster with a Class "E" driver's license, in lieu of a commercial driver's license.

Report amends the bill to:

- 1. Make technical changes.
- 2. Authorize an employee of the Department of Transportation and Development who is operating a bus, in the course and scope of employment, during a gubernatorially declared state of emergency or disaster to only be required to possess a Class "E" driver's license.

Digest of the bill as proposed by the Conference Committee

<u>Present law</u> allows an applicant regularly employed within the last 90 days in a military position requiring operation of a commercial motor vehicle to waive the skills test required to obtain a commercial driver's license.

<u>Proposed law</u> authorizes a person regularly employed within the last 12 months in a military position requiring operation of a commercial motor vehicle to waive the skills test required to obtain a commercial driver's license.

<u>Proposed law</u> specifies that only a Class "E" driver's license is required for an employee of the Dept. of Transportation and Development who is operating a bus, in the course and scope of his employment, during a gubernatorially declared state of emergency or disaster.

(Amends R.S. 32:408(A)(5)(b)(i); Adds R.S. 32:402(C)(6))
