SENATE BILL NO. 47

BY SENATOR ERDEY

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

MOTOR CARRIERS. Requires the assistant secretary of OMV, not later than October 1, 2020, to establish, operate, and maintain commercial motor vehicle information systems and to deny or revoke commercial motor vehicle registration under certain circumstances. (8/1/19)

1 AN ACT

2 To enact R.S. 47:511.4, relative to the registration of commercial motor vehicles; to provide  
3 for the assistant secretary of the office of motor vehicles, not later than October 1,  
4 2020, to establish, operate, and maintain motor carrier, commercial motor vehicle,  
5 and driver information systems and data analysis programs to support safety  
6 regulatory and enforcement activities; to provide for suspension, revocation, or  
7 refusal to issue or renew the registration of a commercial motor vehicle under certain  
8 circumstances; and to provide for related matters.

9 Be it enacted by the Legislature of Louisiana:

10 Section 1. R.S. 47:511.4 is hereby enacted to read as follows:

11 **§511.4. Information systems; denial or revocation of registration**

12 **A. Not later than October 1, 2020, the assistant secretary of the office of**  
13 **motor vehicles shall establish, operate, and maintain motor carrier, commercial**  
14 **motor vehicle, or driver information systems and data analysis programs to**  
15 **support safety regulatory and enforcement activities which comply with the**  
16 **information systems established and operated by the secretary of the United**  
17 **States Department of Transportation pursuant to 49 U.S.C. 31106.**

1                    **B. The failure of an applicant for registration of a commercial motor**  
2                    **vehicle to provide information required by the registrar on the application or**  
3                    **to provide required support documentation shall be grounds for denial of the**  
4                    **application for registration.**

5                    **C. The assistant secretary may suspend, revoke, or refuse to issue or**  
6                    **renew the registration, registration card, registration plate, or permit of a**  
7                    **commercial motor vehicle if the commercial motor carrier responsible for safety**  
8                    **has been prohibited from operating by a federal agency.**

Proposed law requires the assistant secretary of the OMV, not later than October 1, 2020, to establish, operate, and maintain motor carrier, commercial motor vehicle, or driver information systems and data analysis programs to support safety regulatory and enforcement activities which comply with the information systems established and operated by the secretary of the United States Department of Transportation pursuant to 49 U.S.C. 31106.

Proposed law provides that the failure of an applicant for registration of a commercial motor vehicle to provide information required by the registrar on the application or to provide required support documentation shall be grounds for denial of the application for registration.

Proposed law provides that the assistant secretary may suspend, revoke, or refuse to issue or renew the registration, registration card, registration plate, or permit of a commercial motor vehicle if the commercial motor carrier responsible for safety has been prohibited from operating by a federal agency.

Effective August 1, 2019.
