COMMENDATIONS: Commends All Saints Catholic Church in New Orleans on its one hundredth anniversary

1 A RESOLUTION

2 To commend All Saints Catholic Church in New Orleans on its one hundredth anniversary.

3 WHEREAS, it is appropriate to commend All Saints Church upon the momentous
4 celebration of its centennial anniversary and to congratulate its clergy, staff, and members
5 upon this memorable occasion in the church's long and illustrious history; and

6 WHEREAS, in 1919, All Saints Church came into existence, and by the summer of
7 1920, the edifice was dedicated and consecrated; the church was founded for the purpose of
8 evangelization of the African American community on New Orleans's West Bank; and

9 WHEREAS, soon thereafter, All Saints School was established, as true
10 evangelization requires sound religious instruction; and

11 WHEREAS, in its century of existence, All Saints Church, under the leadership of
12 the Society of St. Joseph of the Sacred Heart, has remained committed to the sanctification
13 of its people through worship, religious instruction, and participation in the sacramental life
14 of the Church; parish organizations include the Altar Society, Knights of Peter Claver,
15 Council 36, Ladies Auxiliary of Peter Claver, St. Rita's Court 36, Men of Vision, the Rosary
16 Group, and social outreach and youth ministries; and

17 WHEREAS, the ministers and parish staff meet the spiritual needs of their
18 congregation, and congregants bespeak the love of Jesus Christ, the light of the world,
19 throughout Algiers and beyond; and

20 WHEREAS, the joyous occasion of the centennial of this church merits a special
21 measure of recognition.

1 THEREFORE, BE IT RESOLVED that the House of Representatives of the
2 Legislature of Louisiana does hereby commend All Saints Catholic Church in New Orleans
3 on its one hundredth anniversary; does hereby recognize the century of faith and service the
4 Church has brought to the New Orleans community; and does hereby extend best wishes for
5 the church's continued vitality and success.

6 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
7 to Reverend Peter Weiss, pastor of All Saints Catholic Church.
