1	"A rural business obtaining a rural growth fund investment shall maintain its
2	operating deposit account at the same Louisiana bank that is participating in the loan
3	unless the Louisiana bank agrees to waive this requirement or, if no Louisiana bank
4	is participating in the loan, then the rural business shall maintain its operating deposit
5	account at the Louisiana bank that makes the loan.
6	(b) A rural growth investment shall not include any of the following:
7	(i) A loan secured by accounts receivable or inventory of a rural business.
8	(ii) Any loan that is secured by immovable property or other movable
9	property of a rural business unless a Louisiana bank has an outstanding loan to the
10	rural business, a Louisiana bank participates in the loan, or prior to making the loan,
11	the rural growth fund and the chief executive officer or similar officer of the rural
12	business certifies all of the following:
13	(aa) That the rural business applied for and was declined financing of a
14	similar amount as the proposed rural growth investment from a Louisiana bank with
15	a main office or branch located in the parish or a parish contiguous to the parish
16	containing the location of the rural business's principal businesses operations.
17	(bb) That the rural growth fund submitted a written proposal to participate
18	in the loan to a Louisiana bank with a main office or branch located in the parish or
19	a parish contiguous to the parish containing the location of the rural business's
20	principal business operations which disclosed the name of the rural business, the
21	general terms of the proposed rural growth investment and the loan participation and
22	the Louisiana bank declined to participate or respond within thirty days of receiving
22	
23	the proposal.
24	(iii) All certifications shall identify the Louisiana banks, points of contact
25	and dates of contact at each Louisiana bank. A rural growth fund shall submit the
26	certification to the department prior to making a rural growth investment secured by
27	immovable property or other movable property.
28	(15) "Rural parish" means a nonmetropolitan parish as designated by the
29	United States Office of Management and Budget."
