Subject: Postsecondary affordable textbooks and open resources	

POSTSECONDARY ED OR INCREASE GF EX See Note Page 1 of 1
 Provides relative to postsecondary textbooks and instructional materials. (gov sig)

Proposed law directs the Board of Regents (BOR) through the Louis: The Louisiana Library Network (LOUIS) to develop and implement a plan, in collaboration with the public postsecondary institutions, to increase the development, acquisitions, availability, and accessibility of affordable educational resources (AER) and open educational resources (OER). The plan must include a list of high-impact courses for conversion of course materials to AER and OER; a sustainable program of competitive grants for development, conversion and adoption of AER and OER; and a digital repository for the collection and storage of OER. Proposed law provides for implementation of the plan for the 2020-2021 academic year, including use of a conspicuous symbol or logo to identify courses utilizing AER or OER, communicate to students the availability of AER and OER materials at low or no cost, publish the course schedule and textbook lists on their website, and provide information to LOUIS.

EXPENDITURE EXPLANATION

There will be an indeterminable increase to SGF, SGR, and IAT expenditures for BOR through LOUIS and public postsecondary institutions associated with implementing a collaborative plan, updating course schedule information, communicating with students, and providing additional data to BOR. Additionally, there may be a workload increase for the BOR through LOUIS and public postsecondary institutions related to the development and implementation of a collaborative plan. However, many of these collaborative requirements are already taking place between LOUIS and some public postsecondary institutions, and any additional workload would likely be absorbed utilizing existing staff and resources. Ongoing activities include the purchase of ebooks and the adoption of OER; the Open Textbook Network Project to provide training of faculty, teaching, and learning staff; LCTCS eLearning Innovation Grant and OpenStax program to track savings to students; and participation in evidence-based acquisition (EBA) eBook programs.

Proposed law requires BOR through LOUIS and in collaboration with the public postsecondary institutions to develop and implement a plan to increase the development, acquisitions, availability, and accessibility of affordable educational resources (AER) and open educational resources (OER). The specifics of any such plan are not known at this time, and therefore the expenditure increase is indeterminable. However, LOUIS has identified five (5) programs totaling an estimated \$578,000 annually that would allow LOUIS to support a centralized OER support model. To the extent an adopted plan requires the acquisitions, expands the availability of AER and/or OER, or implements one of the identified programs expenditures will increase. Whether these additional expenditures will be paid by LOUIS (source of funds unknown), the institutions, or some combination of LOUIS and the institutions is unknown.

Furthermore, proposed law requires institutions to use a conspicuous symbol or logo to identify courses utilizing AER or OER, communicate to students the availability of AER and OER materials at low or no cost, publish the course schedule and textbook lists on their website, and provide information to LOUIS. The number of courses utilizing AER or OER at each institution is unknown, but a minimal, indeterminable expenditure increase is anticipated for updating course schedules at institutions offering courses that utilize AER and OER. There may also be additional expenditures related to institutional reporting requirements that may be established by LOUIS. Currently, LOUIS does not have a standardized means of collecting this information. Proposed law would allow LOUIS to collect information directly from the institutions rather than through individual professors which may result in increased expenditures.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
