CRIME RE SEE FISC NOTE GF EX See Note  
Creates the crime of communication interference

Proposed law creates the crime of communication interference described as any person acting to willfully or maliciously injure, destroy, obstruct, hinder, delay the transmission of, or interfere with any of the following communications: (1) communications operated or controlled by the state, its contractors, or its political subdivisions, (2) communications used or intended to be used for military or civil defense functions of the state, and (3) communication controlled by any domestic or foreign corporation, limited liability company, or other legal entity created for the purpose of or engaged in generating, transmitting, providing, and distributing utilities or utility services to the public. Proposed law provides for specific criminal penalties for a first offense as well as second and subsequent offenses. Proposed law provides for specific exceptions for any lawful strike activity, or other lawful concerted activities for the purposes of collective bargaining or other mutual aid and protection which do not injure or destroy any line or system used or intended to be used for and by the state, for military or civil defense functions of the state, or for any private entity as described in proposed law.

**EXPENDITURE EXPLANATION**

Proposed law may result in an indeterminable increase in SGF expenditures for the Department of Public Safety and Corrections - Corrections Services if a person is convicted of communication interference. A first conviction has a maximum imprisonment term of ten years with or without hard labor and a second or subsequent offense has a maximum imprisonment term of fifteen years with or without hard labor. The number of individuals that may be convicted under the provisions of proposed law is indeterminable.

SGF expenditures will increase by \$60.09 per offender per day if an offender is housed in a state facility or \$24.39 for a state offender housed in a local facility. An offender sentenced to the custody of the Department of Public Safety and Corrections - Correction Services for one year would increase SGF expenditures by \$21,992.03 (\$60.09 per day x 366 days) if housed in a state facility and \$8,926.74 (\$24.39 per day x 366 days) if housed in a local facility.

**REVENUE EXPLANATION**

Proposed law may result in an indeterminable increase in local funds revenue as a result of potential fines if a person is convicted of communication interference. The maximum fines assessed are: first offense - \$10,000 and second or subsequent offenses - \$10,000. The potential revenue will accrue to the local governing authority. The potential net effect on sentencing decisions cannot be determined and the potential revenue impact is therefore unknown.
