Amendments proposed by Representative Miguez to Engrossed House Bill No. 610 by Representative Miguez

1 AMENDMENT NO. 1

2 On page 1, delete line 10 in its entirety and insert the following:

3 "322.15(A), 322.24(A), 332.2(A), 332.4(A), 332.18(A), 332.19(A), 332.20(A), and
4 332.22(A), relative to sales and use tax on hotel occupancy;"

5 AMENDMENT NO. 2

6 On page 2, at the end of line 1, delete "and", delete line 2 in its entirety, and insert the
7 following:

8 "302.56(A), 322.15(A), 322.24(A), 332.2(A), 332.4(A), 332.18(A), 332.19(A),
9 332.20(A), and 332.22(A) are hereby amended and reenacted to read"

10 AMENDMENT NO. 3

11 On page 21, after line 28, insert the following:

12 "§322.24. Disposition of certain collections in Terrebonne Parish

13 A. The avails of the tax imposed by this Chapter from the sales of services
14 as defined in R.S. 47:301(14)(a) in Terrebonne Parish under the provisions of R.S.
15 47:321(C), 321.1(C), and 322 shall be credited to the Bond Security and Redemption
16 Fund, and after a sufficient amount is allocated from that fund to pay all the
17 obligations secured by the full faith and credit of the state which become due and
18 payable within any fiscal year, the treasurer shall pay the remainder of such funds
19 into a special fund which is hereby created in the state treasury and designated as the
20 "Terrebonne Parish Visitor Enterprise Fund".

22 §332.2. Disposition of certain collections in East Baton Rouge Parish

23 A. Except as provided in R.S. 47:332.48, the avails of the tax imposed by
24 R.S. 47:331 from the sale of services as defined in R.S. 47:301(14)(a) in the parish
25 of East Baton Rouge under the provisions of R.S. ~~47:331(C)~~ 47:321.1(C), 331(C),
26 and 332 shall be credited to the Bond Security and Redemption Fund, and after a
27 sufficient amount is allocated from that fund to pay all the obligations secured by the
28 full faith and credit of the state which become due and payable within any fiscal
29 year, the treasurer shall pay the remainder of such funds into a special fund which
30 is hereby created in the state treasury and designated as the East Baton Rouge Parish
31 Riverside Centroplex Fund.

1 AMENDMENT NO. 4

2 On page 22, between lines 11 and 12, insert the following:

3 "§332.18. Disposition of certain collections in Iberville Parish

4 A. The avails of the tax imposed by R.S. 47:302, the avails of the tax
5 imposed by R.S. 47:321, and the avails of the tax imposed by R.S. 47:331 from the
6 sales of services as defined in R.S. 47:301(14)(a) in the parish of Iberville under the
7 provisions of R.S. 47:302(C), 321(C), 321.1(C), 322, 331(C), and 332, as applicable,
8 shall be credited to the Bond Security and Redemption Fund, and after a sufficient
9 amount is allocated from that fund to pay all the obligations secured by the full faith
10 and credit of the state which become due and payable within any fiscal year, the
11 treasurer shall pay the remainder of such funds into a special fund which is hereby
12 created in the state treasury and designated as the "Iberville Parish Visitor Enterprise
13 Fund".

15 §332.19. Disposition of certain collections in West Baton Rouge Parish

16 A. The avails of the tax imposed by R.S. 47:302, the avails of the tax
17 imposed by R.S. 47:321, and the avails of the tax imposed by R.S. 47:331 from the
18 sales of services as defined in R.S. 47:301(14)(a) in the parish of West Baton Rouge
19 under the provisions of R.S. 47:302(C), 321(C), 321.1(C), 331(C), and 332, as
20 applicable, shall be credited to the Bond Security and Redemption Fund, and after
21 a sufficient amount is allocated from that fund to pay all the obligations secured by
22 the full faith and credit of the state which become due and payable within any fiscal
23 year, the treasurer shall pay the remainder of such funds into a special fund which
24 is hereby created in the state treasury and designated as the "West Baton Rouge
25 Parish Visitor Enterprise Fund".

27 AMENDMENT NO. 5

28 On page 22, between lines 28 and 29, insert the following:

29 "§332.22. Disposition of certain collections in St. Bernard Parish

30 A. The avails of the tax imposed by R.S. 47:302 and the avails of the tax
31 imposed by R.S. 47:331 from the sales of services as defined in R.S. 47:301(14)(a)
32 in the parish of St. Bernard under the provisions of R.S. 47:302(C), 321.1(C),
33 331(C), and 332, as applicable, shall be credited to the Bond Security and
34 Redemption Fund, and after a sufficient amount is allocated from that fund to pay
35 all the obligations secured by the full faith and credit of the state which become due
36 and payable within any fiscal year, the treasurer shall pay the remainder of such
37 funds into a special fund which is hereby created in the state treasury and designated
38 as the "St. Bernard Parish Enterprise Fund".
