Amendments proposed by House Committee on Appropriations to Engrossed House Bill No. 38 by Representative Hoffmann

1 AMENDMENT NO. 1

2 On page 1, line 2, after "(E)," and before "R.S. 26:793(C)(1)," insert "and (F)"

3 AMENDMENT NO. 2

4 On page 1, line 13, after "(E)" and before "are" insert "and (F)"

5 AMENDMENT NO. 3

6 On page 1, at the end of line 20, insert the following:

7 "The provisions of this Section shall not apply to persons under twenty-one years of
8 age who are active members and veterans of the armed forces."

9 AMENDMENT NO. 4

10 On page 3, between lines 3 and 4, insert the following:

11 "F. (1) It is unlawful for any person under the age of ~~eighteen~~ twenty-one to
12 possess any tobacco product, alternative nicotine product, or vapor product.

13
14 (2) However, it shall not be unlawful for a person under the age of ~~eighteen~~
15 twenty-one to possess a tobacco product, alternative nicotine product, or vapor
16 product under any of the following circumstances:

17
18 (a) When a person under ~~eighteen~~ twenty-one years of age is accompanied
19 by a parent, spouse, or legal guardian twenty-one years of age or older.

21 (b) In private residences.

23 (c) When the tobacco product, alternative nicotine product, or vapor product
24 is handled during the course and scope of his employment and required in the
25 performance of such person's duties.

26 (d) When the person is an active member or veteran of the armed forces.

29 On page 3, line 17, after "age of" and before "twenty-one" delete "eighteen or"

30 AMENDMENT NO. 6

31 On page 3, line 19, after "identification." and before "A" insert the following:

32 "Any person under the age of twenty-one that is an active member or veteran of the
33 armed forces shall carry the person's own military identification card or veteran
34 identification card showing the person's status as a member or veteran of the armed
35 forces."

1 AMENDMENT NO. 7

2 On page 4, at the end of line 18, insert the following:

3 "The provisions of this Section shall not apply to any person under twenty-one years
4 of age who is an active member or veteran of the armed forces."

5 AMENDMENT NO. 8

6 On page 4, at the end of line 24, insert the following:

7 "The provisions of this Section shall not apply to any person under twenty-one years
8 of age who is an active member or veteran of the armed forces."

9 AMENDMENT NO. 9

10 On page 5, line 5, after "twenty-one" and before the period "." insert "or an active member
11 or veteran of the armed forces"

12 AMENDMENT NO. 10

13 On page 5, line 7, after "age" and before "of the" insert "or military status"

14 AMENDMENT NO. 11

15 On page 5, line 10, after "older" and before "and" insert "or an active member or veteran of
16 the armed forces"

17 AMENDMENT NO. 12

18 On page 5, at the end of line 17, insert the following:

19 "The provisions of this Section shall not apply for products sold to any person under
20 twenty-one years of age who is an active member or veteran of the armed forces."
