4	WHEREAS, it was with deep regret and profound sorrow that the members of the
5	Legislature of Louisiana learned of the death of Ernest Nabers Jr. on Saturday, April 28,
6	2019; and
7	WHEREAS, Ernest Nabers Jr. was born on September 28, 1929, in Birmingham,
8	Alabama, the second child born to the union of Ernest Nabers Sr. and Mattie Simmons
9	Nabers; and
10	WHEREAS, he received his elementary and high school training in Altoona,
11	Pennsylvania, where, in high school, he was an outstanding athlete in football and track, and
12	graduated from Altoona High School in 1949; and
13	WHEREAS, it was his mother's desire for him to have the best education possible,
14	so she took her life savings and bought a one-way train ticket to Louisiana so that he could
15	attend college; and
16	WHEREAS, Ernest Nabers Jr. played football and furthered his education at Leland
17	College in Baker, Louisiana, where the motto was Non nobis sed omnibus, (Not for
18	ourselves, but for others), which became his life's work; and

1 WHEREAS, Leland College was also where he met his beautiful wife, Annie Laura 2 Brown; and 3 WHEREAS, after graduating from Leland College and earning a master's degree +30 4 at Southern University in Baton Rouge, he helped many other young students continue their education, as Wilbur Bryson and Lawrence Thornton had done for him; and 5 6 WHEREAS, Ernest Nabers was very active in the community and church; he was an 7 educator and football, basketball, and track coach at Paul Breaux High School; assistant 8 principal at Lafayette High School; principal at Northside High School and N.P. Moss 9 Middle School, and Superintendent of Recreation and Parks for the city of Lafayette; and 10 WHEREAS, he was a member of the Southern University Board of Supervisors, 11 Lafayette Chapter of Southern University Alumni Association, Omega Psi Phi Fraternity, 12 MLK Holiday Committee, Kiwanis S.W., S.A.L.T, and a LHSAA Top 28 Volunteer; and 13 WHEREAS, in his church, Ernest Nabers served on the steward and trustee boards 14 and as an usher; and WHEREAS, he was preceded in death by his parents, two brothers, and six sisters; 15 16 and WHEREAS, Ernest Nabers Jr. is survived by his wife of sixty-six years, Annie Laura 17 18 Brown Nabers; three children: Gabriel (Leona) Nabers, Wilbur Lawrence (Dena) Nabers, 19 and Damita Marie Nabers (Errol) Rogers; seventeen grandchildren: Andrea N.
