Amendments proposed by Representative Leger to Engrossed House Bill No. 599 by Representative Lance Harris

1 AMENDMENT NO. 1

2 On page 1, line 2, after "(C)" and before "and to" insert "and (G)"

3 AMENDMENT NO. 2

4 On page 1, line 4, after "time;" and before "to repeal" insert "to dedicate the avails of certain
5 state sales and use tax;"

6 AMENDMENT NO. 3

7 On page 1, line 7, after "(C)" and before "are" insert "and (G)"

8 AMENDMENT NO. 4

9 On page 2, between lines 11 and 12, insert the following:

10 "(iv) Beginning July 1, 2023, through June 30, 2025, the rate shall be five
11 hundredths of one percent."

12 AMENDMENT NO. 5

13 On page 2, between lines 27 and 28, insert the following:

14 "(iv) Beginning July 1, 2023, through June 30, 2025, the rate shall be five
15 hundredths of one percent."

16 AMENDMENT NO. 6

17 On page 3, between lines 20 and 21, insert the following:

18 "(iv) Beginning July 1, 2023, through June 30, 2025, the rate shall be five
19 hundredths of one percent."

20 AMENDMENT NO. 7

21 On page 4, between lines 6 and 7, insert the following:

22 "(iv) Beginning July 1, 2023, through June 30, 2025, the rate shall be five
23 hundredths of one percent."

1 AMENDMENT NO. 8

2 On page 4, delete line 20 in its entirety and insert the following:

3 "(4) Beginning July 1, 2023, through June 30, 2025, the rate shall be five
4 hundredths of one percent of the amounts paid or charged for the services.

6 G. (1) Except as provided in Paragraph (2) of this Subsection, the ~~The~~ avails
7 of the tax collected under this Section shall be deposited immediately into the state
8 treasury, and, after compliance with the requirements of Article VII, Section 9(B) of
9 the Constitution of Louisiana, the state treasurer shall pay the remainder of the
10 monies into the state general fund.

11 (2) Beginning July 1, 2020, through June 30, 2025, five hundredths of one
12 percent of the avails of the tax imposed in this Section shall be credited to the Bond
13 Security and Redemption Fund, and after a sufficient amount is allocated from that
14 fund to pay all of the obligations secured by the full faith and credit of the state
15 which become due and payable within any fiscal year, the treasurer shall pay the
16 remainder of such funds into the Louisiana Early Childhood Education Fund
17 provided in and subject to the provisions of R.S. 17:407.30.
