5	Senate of the Legislature of Louisiana have learned of the death of Richard F. O'Brien, who
6	passed away on May 27, 2019; and
7	WHEREAS, Richard F. O'Brien was born in Alexandria, Louisiana, on March 20,
8	1954, and was a native of Evergreen, Louisiana, where he grew up on a dairy farm; and
9	WHEREAS, he graduated from Bunkie High School and Louisiana State University;
10	he was an avid LSU fan and loved history; and
11	WHEREAS, Richard F. O'Brien was active in the Louisiana Jaycees from the late
12	1970s through the 1980s, holding many local and statewide offices in the organization,
13	including executive assistant to State President Ronnie Johns in 1981-82; he was the
14	recipient of many local, state, and national awards for his work and contributions to the
15	Louisiana Jaycees and had a tremendous impact on this organization, which at that time had
16	over fourteen thousand members statewide; and
17	WHEREAS, on May 14, 1996, he became a junior commerce senator; and
18	WHEREAS, for the last fourteen years he was a tax preparer at H&R Block; and

1	WHEREAS, Richard F. O'Brien took great pride in his Irish roots and never failed
2	to make someone smile or laugh; he was an active member of the Baton Rouge Irish Club;

4	WHEREAS, he loved to travel the world and was given the opportunity to travel as
5	a navigator for numerous oil companies for eighteen years; and
6	WHEREAS, he married the love of his life Katherine "Kay" E. Waltman O'Brien on
7	April 30, 1994, and their marriage and love produced identical twin daughters, Bonnie and
8	Kathleen O'Brien; and
9	WHEREAS, Richard F. O'Brien took great pride in his family and never failed to be
10	present for the important things in life; he loved his family deeply and was so proud of the
11	family he made; and
12	WHEREAS, he was preceded in death by his mother, Miriam Frank Jordan O'Brien;
13	father, Charles Andrew O'Brien Jr; and step mother Vera Poole O'Brien; and
14	WHEREAS, Richard F. O'Brien is survived by his wife Kay; twin daughters Bonnie
15	and Kathleen; future sons-in-law Michael Grob and Seth Scioneaux; brothers Charles
16	"Andy", John (Sandy), and Billy (Suzie) O'Brien; sister Martha (Mike) LeBlanc; and
