Requires public school governing authorities to establish local special education advisory councils. (gov sig)

Proposed legislation requires each public school governing authority to create a special education advisory council to provide advice and feedback regarding special education policies, procedures, and resources. The number and composition of members shall be determined by the local public school superintendent and the administrative head of each charter or other public school who shall designate a chairperson of the council; 50% shall be parents of students with exceptionalities, 25% shall be teachers, principals, paraprofessionals, and 25% shall be other stakeholders. Requires the councils to meet at least three times a year and to make a report to the school governing authority in May of each year. Effective upon governor's signature.
