## PROPERTY/PUBLIC: Provides for the lease of certain state property in Jefferson Parish

| 6                          | Be it enacted by the Legislature of Louisiana:  |
| 7                          | Section 1. The commissioner of administration, notwithstanding any other provision  |
| 8                          | of law to the contrary, is hereby authorized and empowered to lease any interest, excluding   |
| 9                          | mineral rights, the state may have to all or any portion of the following described parcel of   |
| 10                         | property, once released from the lease with the City of Kenner, in Jefferson Parish, or any   |
| 11                         | property adjacent thereto, to the responsible offeror selected through a request for proposal   |
| 12                         | developed and issued by the City of Kenner, in Jefferson Parish:  |
| 13<br>14<br>15<br>16<br>17 | A parcel of state owned water bottom located on the south shore of<br>Lake Pontchartrain located north of the city of Kenner being the area known<br>as Laketown, more specifically shown on plat of State Lease #1298,<br>containing approximately 40 acres, less area being leased to Treasure Chest<br>Casino. |
| 18                         | Section 2. The commissioner of administration is hereby authorized to enter into  |
| 19                         | such agreements, covenants, conditions, and stipulations and to execute such documents as   |
| 20                         | necessary to properly effectuate any lease, excluding mineral rights, with a term not to  |
| 21                         | exceed ninety-nine years to the property described in Section 1 of this Act, and as more  |
| 22                         | specifically described in any such agreements entered into and documents executed by the  |

- 1 commissioner of administration in exchange for consideration proportionate to the appraised
- 2 value of the property.
- 3 Section 3. This Act shall become effective upon signature by the governor or, if not
- 4 signed by the governor, upon expiration of the time for bills to become law without signature
- 5 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 6 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 7 effective on the day following such approval.
