Abstract: Provides that pretrial motions shall be made or filed within 30 days after receipt of discovery instead of within 15 days after arraignment, unless good cause is shown that 30 days is inadequate.

Present law provides that pretrial motions shall be made or filed within 15 days after arraignment, unless a different time is provided by law or fixed by the court at arraignment upon a showing of good cause why 15 days is inadequate.

Proposed law amends present law to provide that all pretrial motions shall be made within 30 days after the receipt of discovery, unless a different time is provided by law or fixed by the court upon a showing of good cause why 30 days is inadequate.
