EXPENDITURE EXPLANATION

There will be an increase in expenditures for the Office of Student Financial Assistance (OSFA) to pay a higher TOPS award amount for students at Northwest Technical Community College than what is currently authorized and for rule promulgation through the Administrative Code. While TOPS is funded with both statutory dedicated funds and state general fund direct, the LFO assumes increases would be funded with general fund.

Current law establishes the TOPS award amounts to equal the institutional tuition rates charged in the 2016-2017 academic school year. TOPS award amounts for Northwest Technical College is \$2,081 and \$3,214 for community colleges. Act 287 of 2019 provided for the expansion of Northwest Technical College's mission and educational programming and renamed the school the Northwest Louisiana Technical Community College (NLTCC). As a result, the LCTCS Board approved a tuition rate increase from \$2,202 to \$3,335. Proposed legislation would further increase the TOPS award amount for this school to \$3,214, an increase of \$1,133. Based on the number of TOPS recipients attending this school for the past five (5) years, the potential increase to the TOPS program is \$87,241; (average number of recipients 77 * \$1,133 increase). The increase could be higher if there is an increase in the number of TOPS recipients attending, or lower to the extent there are fewer students or they do not attend for the full academic year.

REVENUE EXPLANATION

There will be no increase in revenues to the institution. Students are responsible for the difference between actual cost of attendance and the amount of scholarships and grant awards they receive.
