The <u>current law</u> requires the application for any capital outlay budget request which funding in the capital outlay budget be updated each year that the project remains active in the budget process to reflect all changes in the project that occurred since the previous submission. The <u>proposed legislation</u> limits the current law annual reapplication requirement to those projects that are receiving state funding that are included in the capital outlay budget.
