5 29 in their entirety, and insert in lieu thereof the following:6 "(b) At the licensed eligible facility located in Orleans Parish:7 (i) Twelve and one half percent of the monies earned for such purse
8 supplements shall be used to supplement purses for quarter horse races at that
9 licensed eligible facility, or as authorized by R.S. 4:147.1, up to a maximum of one
10 million dollars per state fiscal year, of which twenty-five percent for each state fiscal
11 year shall be distributed to the Horsemen's Benevolent and Protective Association,
12 1993 Inc., to be used to satisfy the 'Settlement Amount' of \$1,000,000, as defined
13 in and pursuant to the Class Action Settlement Agreement approved by the court in
14 the lawsuit Soileau v. Churchill Downs La. Horseracing Co., et al, Parish of Orleans,
15 Civil District Court, Division G, No. 2014-3873.16 (ii) The remainder of the monies earned for such purse supplements shall be
17 allocated to purse supplements for thoroughbred horse races at that licensed eligible
18 facility, or as authorized by R.S. 4:147.1 per state fiscal year.19 (c) For licensed eligible racing facilities required by law to run more than
20 twenty quarter horse racing days:21 (i) Thirty percent of the monies earned for such purse supplements shall be
22 used to supplement purses for quarter horse races at that licensed eligible facility, or
23 as authorized by R.S. 4:147.1.24 (ii) Seventy percent of the monies earned for such purse supplements shall
25 be used to supplement purses for thoroughbred races as that licensed eligible facility,
26 or as authorized by R.S. 4:147.1.27 (d) Monies earned for purse supplements in accordance with this Paragraph
28 shall be in addition to all other monies currently provided for purses and purse
29 supplements under other provisions of law, shall be the net of sums payable to the
30 Horsemen's Benevolent and Protective Association, 1993 Inc., from purses and
31 purse supplements in accordance with the law, and shall be placed in the appropriate
32 breed account, an interest bearing account, until distributed in accordance with this
33 Section.34 AMENDMENT NO. 1235 On page 4, delete lines 1 through 9 in their entirety and insert in lieu thereof "(e)
36 Distribution of monies earned for purse supplements in accordance with this Paragraph shall
37 be distributed as provided for in Paragraphs (1) and (2) of this Subsection."38 AMENDMENT NO. 1339 On page 4, delete lines 12 through 29 in their entirety, delete page 5 in its entirety, and insert
40 in lieu thereof a set of asterisks "*" * *" and the following:41 "Section 3. This Act shall become effective if and when the Class Action Settlement
42 Agreement in the lawsuit Soileau v. Churchill Downs La. Horseracing Co., et al., Parish of
43 Orleans, Civil District Court, Division G, No. 2014-3873, is approved by the court and
44 becomes final and non-appealable. Contingent upon this approval, as confirmed by a final
45 and non-appealable judgment, any amounts of purses from net video draw poker device
46 revenue collected but not yet distributed on the date the amended statute is made effective
47 shall be allocated and distributed according to the amended statute, using the same formula
48 provided therein."
