SUNSET LAW: Re-creates the Department of Public Safety and Corrections

1 AN ACT 2 To enact R.S. 49:191(12)(b) and to repeal R.S. 49:191(9)(a), relative to the Department of 3 Public Safety and Corrections, including provisions to provide for the re-creation of 4 the Department of Public Safety and Corrections and the statutory entities made a 5 part of the department by law; to provide for the effective termination date for all 6 statutory authority for the existence of such statutory entities; and to provide for 7 related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. Pursuant to R.S. 49:193, the Department of Public Safety and Corrections 10 and the statutory entities made a part of the department by law shall be re-created effective 11 June 30, 2020, and all statutory authority therefor is continued in accordance with the 12 provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950. 13 Section 2. All statutory authority for the existence of the Department of Public 14 Safety and Corrections and the statutory entities made a part of the department as re-created 15 by Section 1 of this Act shall cease as of July 1, 2025, pursuant to R.S. 40:191. However, 16 the Department of Public Safety and Corrections may be re-created prior to such date in 17 accordance with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised 18 Statutes of 1950. 19 Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that 20 those provisions are in conflict with the provisions of this Act. 21 Section 4. R.S. 49:191(12)(b) is hereby enacted to read as follows:

5	operations on July first of each of the following years, and all legislative authority
6	for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of
7	July first of the following year, which shall be the termination date:

11	(b) The Department of Public Safety and Corrections and all statutory
12	entities made a part of the department by law.
13	Section 5. R.S. 49:191(9)(a) is hereby repealed in its entirety.
14	Section 6. This Act shall become effective on June 30, 2020; if vetoed by the
15	governor and subsequently approved by the legislature, this Act shall become effective on
16	June 30, 2020, or on the day following such approval by the legislature, whichever is later.

Abstract: Re-creates the Dept. of Public Safety and Corrections.

<u>Present law</u> (Sunset) provides that the Dept. of Public Safety and Corrections and all the statutory entities made a part of that department by law shall begin to terminate their operations as of July 1, 2020, and that all legislative authority for such entities shall cease as of July 1, 2021, unless the legislature enacts a bill authorizing the re-creation of the department and its statutory entities prior thereto.

<u>Proposed law</u> provides for the general re-creation of the Dept. of Public Safety and Corrections and its statutory entities, effective June 30, 2020, in accordance with the "sunset" law. <u>Proposed law</u> supersedes the provisions of the "sunset" law which set out the procedure for review and re-creation and which require a separate bill to re-create each statutory entity within the department along with additional provisions. <u>Proposed law</u> makes July 1, 2025, the new termination date and termination would begin on July 1, 2024, unless the department is re-created again.

Effective June 30, 2020.

(Adds R.S. 49:191(12)(b); Repeals R.S. 49:191(9)(a))

Summary of Amendments Adopted by House

The House Floor Amendments to the engrossed bill:

1. Change the <u>proposed law</u> termination date of July 1, 2027, to July 1, 2025, and termination would begin on July 1, 2024, <u>rather than</u> July 1, 2026.
