#### 13 **20-XXX FUNDS**

- 14 The state treasurer is hereby authorized and directed to transfer monies from the State
- 15 General Fund (Direct) in the amount of \$6,277,152 into the Voting Technology Fund.
- Section 2. This Act shall become effective upon signature by the governor or, if not
- signed by the governor, upon expiration of the time for bills to become law without signature
- by the governor, as provided in Article III, Section 18 of the Constitution of Louisiana. If
- vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 20 effective on the day following such approval.

Appropriates supplemental funding and provides for means of financing substitutions and other budgetary adjustments for Fiscal Year 2019-2020. Provides for net increases (decreases) as follows: State General Fund (Direct) by (\$6,277,152); Fees and Self-generated Revenues by (\$100,000); and Federal Funds by \$3,212,924.

Increases appropriations from Federal Funds by \$2,712,924 in the Executive Department - Division of Administration.

Increases appropriations from Federal Funds by \$500,000 and decreases the appropriation from Fees and Self-generated Revenues by (\$100,000) in the Department of Veterans Affairs.

Additionally decreases the appropriation from State General Fund (Direct) by (\$6,277,152) in the Department of State and transfers that same amount from State General Fund (Direct) to the Voting Technology Fund.

Effective upon signature of governor or lapse of time for gubernatorial action.
