 18 "Provided, however, that from the monies appropriated herein and subject to approval by the
 19 Centers for Medicare and Medicaid Services, intermediate care facilities for individuals with
 20 developmental disabilities that downsized prior to December 31, 2010, without the benefit
 21 of a Cooperative Endeavor Agreement (CEA), from over 100 beds to less than 35 beds shall
 22 receive the same percent base rate increase that took effect July 1, 2019, applied to the
 23 facilities' specific base rates in effect on June 30, 2019, and shall be applied to each future
 24 rebase period. This shall apply to dates of service on or after July 1, 2020, or the earliest
 25 attainable through administrative rulemaking and the State Plan Amendment. This
 26 differential shall not extend beyond December 31, 2024.

27 Provided, however, that on or after January 1, 2021, the Louisiana Department of Health
 28 shall make no payments pursuant to any Medicaid managed care organization contract unless
 29 the contract meets all of the following criteria: (1) the contract requires utilization of a
 30 transportation broker with a Louisiana-based call center and (2) the requirement to use the
 31 call center is effective no later than January 1, 2022.

32 Provided, further, that on or after January 1, 2021, the Louisiana Department of Health shall
 33 make no payments pursuant to any Medicaid managed care organization contract unless the
 34 contract meets all of the following criteria: (1) the contract prohibits use of out-of-region
 35 nonemergency, non-ambulance medical transportation providers if there is a willing and
 36 available nonemergency, non-ambulance medical transportation provider in the region where
 37 the utilizing Medicaid enrollee is domiciled and (2) such prohibition is effective no later than
 38 January 1, 2022."

16 which amount \$5,000 shall be allocated to the Delhi Municipal Golf Course and the
17 remainder shall be allocated for the Cave Theater, \$10,000 shall be allocated and distributed
18 to the town of Mangham for downtown development, and \$25,000 shall be allocated and
19 distributed to the town of Rayville for downtown development. In the event that total
20 revenues deposited in this fund are insufficient to fully fund such allocations, each entity
21 shall receive the same pro rata share of the monies available which its allocation represents
22 to the total."
