1 A RESOLUTION

2 To express the condolences of the House of Representatives upon the homegoing of Jerry
3 Wayne Yarbrough.

4 WHEREAS, Jerry Wayne Yarbrough was born on May 21, 1968; he was
5 affectionately known as "Big Timer" or "Bernie Mac" to his close friends and family; and

6 WHEREAS, Jerry grew up in the Bellaire neighborhood in Shreveport, but had
7 friends in both the Hollywood area and Greenwood subdivision; he attended Hollywood
8 Elementary and Linwood Junior High and was a member of Woodlawn High School of
9 Shreveport's graduating class of 1986; and

10 WHEREAS, Jerry was a member of the Horsemen Crew, with whom he attended
11 annual hunting trips in November over the past thirty-three years; the Horsemen Crew are
12 spread across the southern United States, with members from Shreveport, Louisiana; Dallas,
13 Texas; San Antonio, Texas; Atlanta, Georgia; Fordyce, Arkansas; Wichita, Kansas; and
14 Oklahoma City, Oklahoma; Jerry also formed a social distancing drinking fellowship with
15 his fellow Horsemen and his childhood friends, Willie King and Andre Baylor, following
16 the COVID-19 quarantine; and

17 WHEREAS, Jerry was an extremely active and involved alumnus of Woodlawn High
18 School; he embraced those closest to him, and he considered both blood relatives and close
19 friends as members of his family; he will be dearly missed, but not forgotten, by all who
20 knew and loved him.

1 THEREFORE, BE IT RESOLVED that the House of Representatives of the
2 Legislature of Louisiana does hereby express heartfelt condolences upon the homegoing of
3 Jerry Wayne Yarbrough and does hereby extend sincere hopes and wishes that his family
