## LEGISLATIVE POWERS: Provides relative to the termination of emergency declarations (Items #1, 2, and 28)

1	AN ACT
2	To amend and reenact R.S. 29:724(B)(2) and 768(B), relative to emergency declarations; to
3	provide relative to the termination of emergency declarations; to provide relative to
4	the effect of terminating emergency declarations; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 29:724(B)(2) and 768(B) are hereby amended and reenacted to read
7	as follows:
8	§724. Powers of the governor

12	(2)(a) The legislature, by petition signed by a majority of the surviving
13	members of either house, may terminate a state of disaster or emergency at any time.
14	This petition terminating the state of emergency or disaster may establish a period
15	during which no other declaration of emergency or disaster may be issued.
16	Thereupon, the governor shall issue an executive order or proclamation ending the
17	state of disaster or emergency.
18	(b) Legislative termination of a state of disaster or emergency does not affect
19	the governor's authority to declare an emergency or disaster based on circumstances
20	other than those for which the terminated declaration was based.

1	(c) Legislative termination of a state of disaster or emergency does not affect
2	the governor's authority to declare a state of public health emergency pursuant to

5	which the terminated declaration was based.

9	B.(1) The legislature, in consultation with the public health authority, by a
10	petition signed by a majority of the surviving members of either house, may
11	terminate a state of public health emergency at any time. This petition terminating
12	the public health emergency may establish a period during which no other
13	declaration of public health emergency may be issued. Thereupon, the governor
14	shall issue an executive order or proclamation ending the state of public health or
15	emergency.
16	(2) Legislative termination of a state of public health emergency does not
17	affect the governor's authority to declare a state of public health emergency based on
18	circumstances other than those for which the terminated declaration was based.
19	(3) Legislative termination of a state of public health emergency does not
20	affect the governor's authority to declare a state of disaster or emergency pursuant
21	to Chapter 6 of this Title nor does it nullify an existing declaration of a state of
22	public health emergency pursuant to this Chapter based on circumstances other than
23	those for which the terminated declaration was based.

Abstract: Specifies that legislative termination of an emergency declaration does not affect the governor's ability to declare a state of disaster or emergency or public health emergency based on other circumstances and that such termination does not nullify other declarations.

<u>Present law</u> also provides that the state of disaster, emergency, or public health emergency shall continue until the governor finds that the threat of danger has passed or the disaster or emergency has been dealt with to the extent that the emergency conditions no longer exist and terminates the state of disaster, emergency, or public health emergency by executive order or proclamation.

<u>Present law</u> provides that a majority of the surviving members of either house of the legislature may terminate a state of disaster or emergency or a state of public health emergency at any time.

<u>Present law</u> further provides that the petition terminating the state of emergency, disaster, or public health emergency may establish a period during which no other declaration of emergency or disaster may be issued and that the governor shall issue an executive order or proclamation ending the state of disaster or emergency.

<u>Proposed law</u> specifies that legislative termination of an emergency order does not affect the governor's ability to declare a state of disaster or emergency or state of public health emergency based on other circumstances nor does it nullify other declarations.
