  an affected unit under an approved work-sharing plan, as distinguished from the
  unemployment benefits otherwise payable under the unemployment insurance provisions of
  this state.

  21 administrator, under which the employer requests the payment of work-sharing benefits to
  22 workers in an affected unit of the employer to avert layoffs."
