HOUSE BILL NO. 24

BY REPRESENTATIVE ZERINGUE

1 AN ACT

2 To appropriate funds from certain sources in specific amounts for the making of
3 supplemental appropriations to the capital outlay budget for Fiscal Year 2020-2021;
4 to provide for an effective date; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. The following revisions are hereby made to Act No. 2 of the 2020 First
7 Extraordinary Session of the Legislature for the purpose of making supplemental capital
8 outlay appropriations for Fiscal Year 2020-2021:

9 A. Notwithstanding any provision of law to the contrary, including the provisions
10 of the Capital Outlay Act, the appropriation to 01/107 DIVISION OF
11 ADMINISTRATION for the Repair, Restoration and Replacement for Declared
12 Disasters, Planning, Construction, Renovation, and Acquisition (Statewide) project is
13 hereby amended and reenacted to include an appropriation made out of the Capital
14 Outlay Savings Fund:

15 On page 7, delete line 51 in its entirety and insert the following:

16	"Priority 1	\$ 97,059,530
17	Payable from Capital Outlay Savings Fund	\$ 20,000,000
18	Total	<u>\$ 117,059,530</u>

19 Provided, however, that \$20,000,000 of the appropriation for this project from the
20 Capital Outlay Savings Fund shall be used to fund the construction, repair, or
21 restoration of state-owned buildings damaged or destroyed by Hurricane Laura or
22 Hurricane Delta."

23 B. Notwithstanding any provision of law to the contrary, including the provisions
24 of the Capital Outlay Act, the appropriation to 01/109 COASTAL PROTECTION AND
25 RESTORATION AUTHORITY for the Coastal Protection Projects, Planning and
26 Construction (Statewide) project is hereby amended and reenacted to include an
27 appropriation made out of State General Fund (Direct) Non-Recurring Revenues:

28 On page 8, delete lines 35 and 36 in their entirety and insert the following:

1	"Payable from Federal Funds	\$ 362,928,040
2	Payable from State General Fund (Direct)	
3	Non-Recurring Revenues	\$ 3,000,000
4	Total	<u>\$ 1,078,416,654</u>

5 Provided, however, that \$3,000,000 of the State General Fund (Direct) Non-Recurring
6 Revenues shall be used to fund levee improvements in the North Lafourche Conservation
7 Levee and Drainage District."

8 C. On page 76, delete lines 21 through 28 in their entirety.

9 Section 2. This Act shall become effective upon signature by the governor or, if not
10 signed by the governor, upon expiration of the time for bills to become law without signature
11 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
12 vetoed by the governor and subsequently approved by the legislature, this Act shall become
13 effective on the day following such approval.
