1	A CONCURRENT RESOLUTION
2	To commend the National Association of Real Estate Brokers and to recognize April 11-17,
3	2021, as Realtist Week at the state capitol.
4	WHEREAS, formed in 1947, the National Association of Real Estate Brokers, or
5	NAREB, is the oldest minority real estate trade association in the country; and
6	WHEREAS, NAREB's founding motto, Democracy in Housing, succinctly expresses
7	the organization's purpose and focus; and
8	WHEREAS, NAREB's approach to increasing black wealth includes financial
9	education, homeownership preparation and counseling, outreach to faith-based, civic, and
10	community organizations, and education on the importance of home ownership; and
11	WHEREAS, unfortunately, homeownership for black Americans has been on a
12	steady decline since 2004, when it reached its peak of nearly fifty percent; and
13	WHEREAS, according to the U.S. Census Bureau, during the fourth quarter of 2020,
14	the black homeownership rate is 44.1%, which compares unfavorably with the non-Hispanic
15	white homeownership rate of 74.5%; and
16	WHEREAS, NAREB's 2 Million New Black Homeowners Program, or 2MN5, was
17	initiated to reverse the wealth drain among black Americans; and

1	WHEREAS, the New Orleans Real Estate Broker Association, a local chapter of
2	NAREB, will host Realtist Week on April 11-17, 2021; and
3	WHEREAS, Realtist Week will be held to raise awareness that building black wealth
4	through homeownership not only improves the community's economic fabric, but also
5	enhances the financial futures of members of the community; and
6	WHEREAS, Realtist Week also commemorates the fifty-second anniversary of the
7	passage of the Fair Housing Act, which made it housing discrimination on the basis of race,
8	color, national origin, gender, religion, family status, or disability illegal; and
9	WHEREAS, the New Orleans Real Estate Brokers Association joins NAREB
10	chapters nationwide in observing Realtist Week; and
11	WHEREAS, Realtist Week will feature a week-long series of events that are
12	designed to reach black residents where they live, work, socialize, and worship; and
13	WHEREAS, throughout the week, a series of activities will heighten public
14	awareness about the importance of homeownership as a pivotal foundation for wealth-
15	building; and
16	WHEREAS, in addition, members of the association will meet with policymakers
17	and elected officials to ensure that affordable and sustainable homeownership is supported
18	at the legislative level, through regulatory action or through the use of city planning.
19	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
20	commend the National Association of Real Estate Brokers for its valuable efforts to promote
21	homeownership in minority communities and hereby recognizes April 11-17, 2021, as
22	Realtist Week at the state capitol.
