To amend and reenact R.S. 32:1252(27), relative to marine products; to provide for certain definitions; to provide for a licensing exception for certain marine products; to provide terms and conditions; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 32:1252(27) is hereby amended and reenacted to read as follows: §1252. Definitions

The following words, terms, and phrases, when used in this Chapter, shall have the meanings respectively ascribed to them in this Section, except where the context clearly indicates a different meaning:

* * *

(27) "Marine product" means a new or used watercraft, boat, marine motor, and a boat or watercraft trailer. The term also includes an outboard motor or a boat with an inboard/outboard motor attached to it. The term shall not mean a watercraft or marine motor designed for use if the watercraft or marine motor is used primarily for commercial or governmental purposes or a new or used watercraft or boat adapted to be powered only by the occupant's energy.

<u>Present law</u> provides for the licensing and regulation of marine products by the La. Motor Vehicle Commission.

<u>Present law</u> defines "marine product" as a new or used watercraft, boat, marine motor, and a boat or watercraft trailer. Provides an exclusion for watercraft designed for use primarily for commercial or governmental purposes or a new or used watercraft or boat adapted to be powered only by the occupant's energy.

<u>Proposed law</u> adds an exclusion to the definition of "marine product" for a marine motor used primarily for commercial or governmental purposes.

<u>Proposed law</u> provides that the <u>present law</u> exclusion for a watercraft will apply only if the watercraft is used primarily for commercial or governmental purposes.

Effective August 1, 2021.

<u>Committee Amendments Proposed by Senate Committee on Commerce, Consumer Protection, and International Affairs to the original bill</u>

1. Excludes from the definition of "marine product" a watercraft or marine motor if such watercraft or motor is used primarily for commercial or governmental purposes.
