<u>Present law</u> provides that the Alexandria/Pineville Area Convention and Visitors Bureau will be composed of seven members appointed as follows:

- (1) Two members appointed by the Greater Alexandria/Pineville Chamber of Commerce.
- (2) One member appointed by the CENLA chapter of the Louisiana Restaurant Association.
- (3) Two members appointed by the Alexandria Hotel-Motel Association.
- (4) One member appointed by the governing authority of Rapides Parish who will be a representative of the Coliseum Management.
- (5) One member appointed by the Central Louisiana Attractions Associations.

<u>Proposed law</u> makes changes to the Alexandria/Pineville Area Convention and Visitors Bureau board <u>from</u> a seven member board <u>to</u> a nine member board appointed as follows:

- (1) One member appointed by the Greater Alexandria/Pineville Chamber of Commerce.
- (2) One member appointed by the CENLA chapter of the Louisiana Restaurant Association.
- (3) Two members appointed by the Alexandria Hotel-Motel Association.
- (4) Two members appointed by the governing authority of Rapides Parish.
- (5) One member appointed by the Central Louisiana Attractions Associations.
- (6) One member appointed by the mayor of Alexandria.
- (7) One member appointed by the mayor of Pineville.
