Proposed legislation requires each public school governing authority to submit an annual report to the Department of Education (LDE) no later than September 1. The report shall include the following information by grade level: (1) total students identified as dyslexic through a Section 504 plan and the number of students initially identified in the prior school year; and (2) total students with an Individualized Education Plan (IEP) identified as dyslexic by means of a specific learning disability and the number of such students initially identified in the prior school year.
