5	commissioners; to provide relative to terms of the board of commissioners; to
6	provide relative to meetings; and to provide for related matters.

8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 46:1098.5(B)(6) and (C), 1098.6(B)(1)(a), and 1098.7(21) and (23)
10	are hereby amended and reenacted to read as follows:
11	§1098.5. Appointing authority

13	B. The appointing authority shall be composed of seven members as follows:

15	(6) Two appointees of the <u>The</u> state senator and the state representative in
16	whose district Slidell Memorial Hospital resides, or their designees.
17	C. The state senator shall be responsible for ensuring the proper appointment
18	of all members of the <del>nominating committee</del> <b>appointing authority</b> pursuant to this
19	Section, calling and providing proper notice of all meetings of the nominating
20	committee appointing authority, and maintaining all appropriate documentation of

5	§1098.6. Qualifications of board of commissioners

8	(a) No member of the board, whether appointed by recommendation of the
9	nominating committee or the medical staff, shall serve more than three consecutive
10	terms. One term shall consist of four years, with the exception of Subparagraphs
11	(b) and (c) of this Paragraph.

13	§1098.7. Rights, powers, and duties of board of commissioners
14	The district acting by and through its board shall have and exercise all rights,
15	powers, and duties for the carrying out of its objects and purposes including but not
16	limited to the following:
17	* * *
18	(21) Notwithstanding any other provisions of law to the contrary, to annually
19	appoint, if desired, a former member of the board to serve as a nonvoting
20	"Commissioner Emeritus" to advise and provide historical perspective to the board
21	when requested by the chairman. Such person shall be paid a per diem equal to that
22	paid to other board members for attendance at the meeting together with reasonable
23	expenses to attend any event attended by the board of commissioners. The
24	"Commissioner Emeritus" may not serve longer than one year.

26	(23) To hold regular meetings at least monthly and as often as necessary for
27	the conduct of its business. Special meetings may be called upon with <u>at least</u>
28	forty-eight hour notice by the chairperson, or in his absence, by the vice chairperson,
29	or upon the written authorization of a majority of the members of the board.
30	Emergency meetings, providing notice of at least twenty-four hours, may be called
