3 adopted by the Senate on May 25, 2021, on page 1, at the end of line 7, delete "39:100.11  
4 and" and insert "39:100.11,"

5 AMENDMENT NO. 2

6 In Senate Committee Amendment No. 5 proposed by the Senate Committee on Finance and  
7 adopted by the Senate on May 25, 2021, on page 1, at the end of line 28 delete, the  
8 quotation mark, and insert the following:

9 "L) Notwithstanding any provision of law to the contrary, the state treasurer is  
10 hereby authorized and directed to transfer \$13,500,000 from the State General Fund (Direct)  
11 into the Capital Outlay Savings Fund."

2 No. 9562D; and Secretary, Department of Revenue, State of Louisiana v. Jazz Casino  
3 Company, LLC and JCC Fulton Development, LLC, 19th JDC, Docket No. 670,597  
4 (hereinafter the "Jazz Casino Litigation"), shall be deposited into the fund. No proceeds  
5 shall be deposited into the fund resulting from the Jazz Casino Litigation that are attributable  
6 to outstanding debt secured by and payable from such proceeds, court costs, or attorney's  
7 fees."

8 AMENDMENT NO. 8

9 On page 51, between lines 11 and 12, insert the following:

11 "Section 21. Subpart P of Part II-A of Chapter 1 of Subtitle I of Title 39 of the  
12 Louisiana Revised Statutes of 1950, comprised of R.S. 39:100.71, is hereby enacted to read  
13 as follows:

15 SUBPART P. BLUE TARP FUND

16  
17 §100. 71. Blue Tarp Fund; purpose

18  
19 A. There is hereby created in the state treasury, as a special fund, the "Blue Tarp  
20 Fund", hereinafter referred to in this Section as the "fund".

21 B. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
22 authorized and directed to transfer \$500,000 from the Louisiana Mega-Project Development  
23 Fund into the Blue Tarp Fund.

24 C. Monies in the fund shall be invested in the same manner as monies in the state  
25 general fund. Interest earned on investment of monies in the fund shall be credited to the  
26 fund. Unexpended and unencumbered monies in the fund at the end of the fiscal year shall  
27 remain in the fund.

28 D. Monies in the fund shall be appropriated and used for roof repairs for  
29 homeowners. The division of administration - office of community development shall  
30 develop a plan and promulgate rules for the distribution of funds.

32 Section 22. Subpart P-3 of Part II-A of Chapter 1 of Subtitle I of Title 39 of the  
33 Louisiana Revised Statutes of 1950, comprised of R.S. 39:100.101, is hereby enacted to read  
34 as follows:

36 SUBPART P-3. POWER-BASED FUND

37  
38 §100.101. Power-Based Fund; purpose

39  
40 A. There is hereby created in the state treasury, as a special fund, the "Power-Based  
41 Fund", hereinafter referred to in this Section as the "fund".

42 B. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
43 authorized and directed to transfer \$500,000 from the Louisiana Mega-Project Development  
44 Fund into the Power-Based Fund.

45 C. Monies in the fund shall be invested in the same manner as monies in the state  
46 general fund. Interest earned on investment of monies in the fund shall be credited to the  
47 fund. Unexpended and unencumbered monies in the fund at the end of the fiscal year shall  
48 remain in the fund.

49 D. Monies in the fund shall be appropriated and used for the establishment of Title  
50 IX offices at every public postsecondary institution in the state. The Board of Regents  
51 shall develop a plan and promulgate rules for the distribution of funds."
