Abstract: Modifies the definition of "forest products" to include timber products and provides a description of the applicable products included in a timber harvest season permit.

 $\underline{\text{Present law}}$ defines the terms used in $\underline{\text{present law}}$ for agriculture and forestry related concepts.

<u>Proposed law</u> retains <u>present law</u> and adds timber products to the definition of "forest products".

<u>Present law</u> provides the requirements and fees for obtaining a special permit for the operation of vehicles or combination where the dimensions or weights exceed the limits imposed by present law.

<u>Proposed law</u> retains <u>present law</u> and clarifies that timber products are the type of products applicable to timber harvest season permits.
