ENVIRONMENT/LITTERING: Separates funding sources for environmental education and litter abatement

AN ACT

2	To amend and reenact R.S. 30:2531(C)(4) and 2532(A)(5), R.S. 32:412(A)(1), (2), (5), and
3	(6), and (B)(1), (2), and (7)(e)(i)(cc) and (ee) and (ii)(cc) and (ee), R.S. 47:463.43(A)
4	and (D), and R.S. 56:10(B)(15), to enact R.S. 56:10(B)(17), and to repeal R.S.
5	30:2532(B), relative to funding for environmental education and litter abatement; to
6	separate the litter abatement and education account into an account for litter
7	abatement and an account for environmental education; to redirect existing fines,
8	fees, and donations dedicated for these purposes into the separate accounts; and to
9	provide for related matters.
0	Be it enacted by the Legislature of Louisiana:
1	Section 1. R.S. 30:2531(C)(4) and 2532(A)(5) are hereby amended and reenacted

21	cents. Eleven dollars and fifteen cents of the fee shall be paid to the Louisiana State	
22	Police Retirement System Fund. One dollar and fifty cents of the fee shall be	
23	forwarded by the department to the litter abatement and education account which is	
24	created with within the Conservation Fund through the provisions of R.S.

26	(2) The fee for Class "D" driver's licenses, or renewal of a Class "D" driver's

- (5) Every applicant for a Class "E" driver's license, or for a renewal of a Class "E" driver's license, except those bona fide residents of the city of New Orleans, shall pay for such basic license a fee of twenty dollars and twenty-five cents, which shall be the cost of such basic license. Five dollars and sixty-three cents of the fee shall be paid to the Louisiana State Police Retirement System Fund. One dollar and fifty cents of the fee shall be forwarded by the department to the litter abatement and education account which is created within the Conservation Fund through the provisions of R.S. 56:10(B)(15).
- (6) The fee for a Class "E" driver's license, or renewal of a Class "E" driver's license, issued to bona fide residents of the city of New Orleans shall be twenty dollars and twenty-five cents, three dollars and seventy-five cents of which shall be paid by the department to the board of trustees of the police pension funds of the city of New Orleans. Three dollars and seventy-five cents of the fee shall be paid to the Louisiana State Police Retirement System Fund. One dollar and fifty cents of the fee shall be forwarded by the department to the litter abatement and education account which is created within the Conservation Fund through the provisions of R.S. 56:10(B)(15).

B.(1) Every applicant for a Class "A", "B", or "C" commercial driver's license, or for a renewal of a basic Class "A", "B", or "C" commercial driver's license, except for those bona fide residents of the city of New Orleans, shall pay for such basic license a fee of sixty-one dollars and fifty cents. Sixteen dollars and twenty cents of the fee shall be paid to the Louisiana State Police Retirement System Fund. One dollar and fifty cents of the fee shall be forwarded by the department to

Section 3. R.S. 47:463.43(A) and (D) are hereby amended and reenacted to read as follows:

§463.43. Special license plates; environmental education and litter reduction section account

A. The Department of Public Safety and Corrections shall establish a special prestige motor vehicle license plate for environmental education by the Department of Wildlife and Fisheries for the purposes provided in R.S. 56:10(B)(15)(17). The license plates shall be restricted to use on passenger cars, pickup trucks, vans, and recreational vehicles.

D. The department shall collect the donation for each license plate and forward the donation as provided in Subsection C of this Section to the Department of Wildlife and Fisheries. The one dollar handling fee as provided in Subsection C

**Abstract:** Creates separate accounts for environmental education and litter abatement and redirects existing funding between these two accounts.

<u>Present law</u> creates within the Conservation Fund an account entitled the "litter abatement and education account" to be used towards certain environmental education and litter abatement programs and goals. <u>Present law</u> further directs donations from certain prestige license plates, a portion of littering fines and court costs paid, and a portion of fees collected for the issuance and renewal of driver's licenses into this account.

<u>Proposed law</u> creates the "litter abatement account" within the Conservation Fund and directs that a portion of littering fines and court costs paid and a portion of the fees collected for the issuance and renewal of driver's licenses into this account. <u>Proposed law</u> further specifies that funds in the account be used for litter abatement grants, litter abatement and enforcement, and to support community-based litter abatement programs.

<u>Proposed law</u> creates the "environmental education account" within the Conservation Fund and directs that donations from the environmental education special prestige license plate be credited to the account. <u>Proposed law</u> specifies that funds in the account be used for statewide environmental education, environmental education grant programs, development of environmental education curriculum and teacher education and professional development requirements, and litter education and awareness programs and materials.

<u>Present law</u> provides fines and special court costs for intentional littering and directs portions of those fines and special court costs to the litter abatement and education account.

<u>Proposed law</u> retains the fines and special court costs for intentional littering under <u>present law</u>, but directs the portions dedicated to the litter abatement and education account under <u>present law</u> to the litter abatement account instead.

<u>Present law</u> provides for fees to be charged for the issuance or renewal of driver's licenses and directs a portion of those fees to the litter abatement and education account.

<u>Proposed law</u> retains the same fees, but directs the portions dedicated to the litter abatement and education account under <u>present law</u> to the litter abatement account instead.

<u>Present law</u> provides for a special prestige license plate for environmental education and dedicates a portion of the donation received for such plates to the litter abatement and education account.

<u>Proposed law</u> retains the special prestige license plate and the donation required for the plate, but directs the portions dedicated to the litter abatement and education account under <u>present</u> law to the environmental education account instead.

<u>Present law</u> creates a litter abatement and education account within the state treasury and directs fines from littering violations into this account.

## Proposed law repeals present law.
