## **EXPENDITURE EXPLANATION**

Proposed law will result in a one-time programming change of \$3,246 (assumed to be SGF) in the Department of Public Safety (DPS), Office of Motor Vehicles (OMV). The proposed law exempts foreign nationals under an H-2A visa that possess a valid foreign driver's license from the existing requirement of completing a driver's education course or prelicensing training course before being issued a Louisiana driver's license. An H-2A visa allows a foreign national worker into the United States for temporary agricultural work.

DPS indicates the proposed law requires coding changes of approximately 40 hours of overtime for coding changes to the OMV Driver's License Issuance platform at an average cost of \$80 per hour for an IT Management Consultant 1 Developer position ( $$80 \times 40 = $3,200 \times 1.45\%$  Medicare = \$3,246). The Legislative Fiscal Office believes that the department can potentially accomplish these tasks utilizing existing resources and budget authority as similar changes are enacted annually by legislative instruments and paid from base funding. To the extent that numerous pieces of legislation are enacted that require additional programming efforts, DPS may require additional resources.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
