PROPERTY/PUBLIC: Provides relative to the transfer of certain state property in Cameron Parish

AN ACT

2	To authorize and provide for the transfer of certain state property; to authorize the transfer
3	of certain state property in Cameron Parish; to provide for the property description;
4	to provide for the reservation of mineral rights; to provide for terms and conditions;
5	to provide an effective date; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. The secretary of the Department of Transportation and Development and
8	the commissioner of administration, notwithstanding any provision of law to the contrary,
9	are hereby authorized and empowered to convey, transfer, assign, lease, or deliver any
10	interest, excluding mineral rights, the state may have in and to all or any portion of the
11	following described property to Cameron Parish Waterworks District No. 10:
12 13 14 15	That certain parcel of land owned by Louisiana Department of Transportation & Development (LADOTD) containing 1.002 acres, situated in Section 3, Township 15 South, Range 11 West, Cameron Parish, Louisiana, said parcel being further described as follows:
16 17 18 19 20 21	Commencing at an existing NGS Monument referred to as "BRAMA", said point hereinafter being known as the Point of Commencement and referred to as the P.O.C; Thence a bearing of North 11 degrees 32 minutes 00 seconds East a distance of 5,782.36 feet to a point on the apparent East Right-of-Line of Louisiana Highway No. 27, said point hereinafter being known as the Point of Beginning and referred to as the P.O.B.;
23 24 25	Thence along the apparent East Right-of-Line of Louisiana Highway No. 27, a bearing of North 15 degrees 13 minutes 48 seconds West a distance of 153.32 feet to a point;

The secretary of the Department of Transportation and Development and 11 the commissioner of administration are hereby authorized to enter into such agreements, 12 covenants, conditions, and stipulations and to execute such documents as necessary to 13 properly effectuate any conveyance, transfer, assignment, lease, or delivery of title, 14 excluding mineral rights, to the property described in Section 1 of this Act, and as more 15 specifically described in any such agreements entered into and documents executed by and 16 between the secretary of the Department of Transportation and Development, the 17 commissioner of administration, and Cameron Parish Waterworks District No. 10, in exchange for consideration proportionate to the appraised value of the property, or as 18 19 otherwise provided by law. 20 Section 3. This Act shall become effective upon signature by the governor or, if not 21 signed by the governor, upon expiration of the time for bills to become law without signature 22 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become 23 24 effective on the day following such approval.

- 2. Change the date of the survey of Tract 2-1 <u>from</u> February 21, 2022 <u>to</u> February 2022.
