Provides that the party affiliation for candidates for judicial office shall not be printed on the ballot

Present law requires the political party of a candidate be listed on primary and general ballots on the same line and immediately after or below the candidate's name. Proposed law modifies present law, prohibiting the listing of the political party for judicial candidates on the ballot.

EXPENDITURE EXPLANATION

Proposed law will result in a one-time increase in expenditures for the Department of State for IT costs associated with removing party identification for judicial candidates from the ballots. The department estimates it will cost \$68,000 (\$100/hour x 680 hours) to complete the necessary IT changes to the ballots.
