7 "(iii) The estimated cost of site closure and remediation that includes the 8 estimated cost of removing the solar power generation facility and associated 9 infrastructure from the property and restoring the property to as near as reasonably 10 possible to the condition of the property prior to the commencement of construction of the facility. The secretary shall adjust the estimated cost based upon any updated 11 12 decommissioning plan submitted pursuant to Paragraph (D)(2) of this Section. Any increase in the amount of financial security required shall be secured by the permit 13 holder within thirty days of notification of the increase." 14
