HIGHER EDUCATION: Provides relative to the Louisiana State University system

1 AN ACT

2 To amend and reenact R.S. 17:3215, relative to institutions under the supervision and  
3 management of the Board of Supervisors of Louisiana State University; to provide  
4 for transfers of certain institutions; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 17:3215 is hereby amended and reenacted to read as follows:

7 §3215. Louisiana State University system

8 The Louisiana State University system is composed of the institutions under  
9 the supervision and management of the Board of Supervisors of Louisiana State  
10 University and Agricultural and Mechanical College as follows:

11 (1) Louisiana State University and Agricultural and Mechanical College,  
12 located at Baton Rouge and designated as the premier flagship university for the  
13 state.

14 ~~(3)~~ (2) Louisiana State University at Alexandria, located at Chambers.

15 ~~(4)~~ (3) Louisiana State University at Eunice.

16 ~~(5)~~ (4) Louisiana State University at Shreveport.

17 ~~(6)~~ (5) Louisiana State University Health Sciences Center at New Orleans,  
18 which shall include medical and related health schools and programs located in New  
19 Orleans including those state's medical centers transferred to the Board of  
20 Supervisors of Louisiana State University and Agricultural and Mechanical College

1 as provided in Subpart C-2 of Part II of Chapter 4 of this Title, subject to provisions  
2 of R.S. 17:1519 et seq.

3 ~~(7)~~ (6) Louisiana State University Health Sciences Center at Shreveport,  
4 which shall include the medical school and related schools at Shreveport, Louisiana  
5 State University Hospital at Shreveport, E.A. Conway Medical Center at Monroe,  
6 and Huey P. Long Medical Center in Pineville.

7 ~~(8)~~ (7) The Center for Agricultural Sciences and Rural Development which  
8 administers the agricultural extension and research programs of the board throughout  
9 the state. The center shall also be responsible for conducting river water research.

10 ~~(9)~~ (8) Any other college, university, school, institution, or program ~~now or~~  
11 ~~hereafter~~ under the supervision and management of the Board of Supervisors of  
12 Louisiana State University and Agricultural and Mechanical College.
