HOUSE BILL NO. 144

ELECTIONS/CANDIDATES: Requires candidates for public office to provide a valid email address when qualifying for office

1 AN ACT 2 To amend and reenact R.S. 18:463(A)(1)(a), relative to notice of candidacy, to provide for 3 required information on a notice of candidacy; to provide for an effective date; and 4 to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 18:463(A)(1)(a) is hereby amended and reenacted to read as follows: 7 §463. Notice of candidacy; campaign finance disclosure; political advertising; 8 penalties 9 A.(1)(a) A notice of candidacy shall be in writing and shall state the 10 candidate's name, the office he seeks, the address of his domicile, his telephone 11 number, his electronic mail address if available, and the parish, ward, and precinct 12 where he is registered to vote. The candidate shall list on the notice of candidacy the 13 name of the political party if he is registered as being affiliated with a recognized 14 political party, "other" if he is registered as being affiliated with a political party that 15 is not a recognized political party, or "no party" or an abbreviation thereof if he is 16 registered with no political party affiliation. No candidate shall change or add his 17 political party designation, for purposes of printing on the election ballot as required 18 by R.S. 18:551(D), after he has qualified for the election.

- 1 Section 2. This Act shall become effective upon signature by the governor or, if not
- 2 signed by the governor, upon expiration of the time for bills to become law without signature
- 3 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 4 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 5 effective on the day following such approval.

Abstract: Requires a candidate to provide an email address when qualifying for office

<u>Present law</u> requires that a candidate provide the following in his notice of candidacy: his name, the office he seeks, the address of his domicile, his telephone number, his electronic mail address if available, and the parish, ward, and precinct where he is registered to vote.

<u>Proposed law</u> retains <u>present law</u> but makes it mandatory to provide a valid email address when qualifying.

Effective upon signature of governor or lapse of time for gubernatorial action.

(Amends R.S. 18:463(A)(1)(a))
