CHILDREN/DCFS: Establishes a continuum of care program for certain pregnant women and parents of young children

AN ACT

2 To enact Chapter 15 of Title 46 of the Louisiana Revised Statutes of 1950, to be comprised 3 of R.S. 46:1451 through 1455, relative to assistance programs of the Department of 4 Children and Family Services; to establish within the department an assistance 5 program for certain pregnant women and parents; to provide for services to be 6 delivered through the program; to require reporting to certain legislative committees 7 concerning the program; to require administrative rulemaking; and to provide for 8 related matters. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. Chapter 15 of Title 46 of the Louisiana Revised Statutes of 1950, 11 comprised of R.S. 46:1451 through 1455, is hereby enacted to read as follows: 12 CHAPTER 15. CONTINUUM OF CARE FOR 13 CERTAIN PREGNANT WOMEN AND PARENTS 14 §1451. Definitions 15 As used in this Chapter, the following terms have the meaning ascribed to 16 them in this Section: 17 (1) "Department" means the Department of Children and Family Services. 18 (2) "Program" means the continuum of care program established and 19 provided for in this Chapter.

5	§1452. Continuum of care program; purpose and goals; means of finance
6	A. The legislature hereby creates within the department a continuum of care
7	program for certain pregnant women and parents, referred to hereafter in this Chapter
8	as the "program".
9	B.(1) The purpose of the program is to facilitate the operation of a statewide
10	telecare support network that provides community outreach, consultations, and care
11	coordination for women who are challenged with unexpected pregnancies.
12	(2) The program shall be designed to accomplish all of the following goals:
13	(a) Encourage healthy childbirth.
14	(b) Support childbirth as an alternative to abortion.
15	(c) Promote family formation.
16	(d) Assist parents in establishing successful parenting techniques.
17	(e) Increase the economic self-sufficiency of families.
18	C. The program shall encompass the alternatives to abortion TANF initiative
19	provided for in LAC 67:III.5569 along with a statewide telecare support network.
20	The department shall provide in rule for the functions and administration of the
21	telecare support network.
22	D. The department shall finance the program with TANF funds and any
23	other monies appropriated to it by the legislature for operation of the program.
24	§1453. Services and supports; eligibility
25	A. The program shall provide direct services, supports, social services case
26	management, and referrals to biological parents of unborn children and biological
27	or adoptive parents of children under the age of two years.
28	B. The components of the program shall include, without limitation, all of
29	the following:

1	(1) Outreach to at-risk populations eligible for the program.
2	(2) Utilization of registered nurses, who shall be licensed in accordance with
3	R.S. 37:911 et seq., to perform the following functions:
4	(a) Assessment and evaluation of needs related to pregnancy or parenting.
5	(b) Provision of medically accurate, pregnancy-related medical information
6	to program participants.
7	(3) Utilization of social workers, who shall be licensed in accordance with
8	R.S. 37:2701 et seq., or other licensed individuals with equivalent experience to
9	perform the following functions:
10	(a) Development of a care plan, resources, and supports for program
11	participants to address identified needs.
12	(b) Referrals to appropriate local resources including, without limitation,
13	state and federal benefits programs and local charitable organizations.
14	(c) Assistance in applying for state and federal benefits programs.
15	(d) Assistance in accomplishing elements of the care plan.
16	C. In order to be eligible to receive services through the program, an
17	individual shall, at the time of initial contact with the program, meet all of the
18	following requirements:
19	(1) Is a resident of this state.
20	(2) Is a biological parent of an unborn child or a biological or adoptive
21	parent of a child under the age of two years.
22	D. Any program participant who terminates a pregnancy shall be eligible to
23	continue receiving services through the program for a period of six months from the
24	date of the pregnancy termination.
25	§1454. Reporting
26	On or before December 1, 2022, and annually thereafter, the department shall
27	submit to the House and Senate committees on health and welfare a report on the
28	status and operation of the program. Each report required by this Section shall
29	include, at minimum, all of the following:

1 (1) A detailed itemization of expenditures associated with the program. 2 (2) The number of individuals served by the program, and for the individuals 3 served, the types of services provided to each. 4 (3) Any information regarding the program requested by and provided to any elected member of the legislature during the period addressed in the report. 5 6 (4) Any other information that the secretary of the department deems 7 necessary or appropriate for facilitating evaluation of the program. 8 §1455. Rulemaking 9 The department shall promulgate in accordance with the Administrative 10 Procedure Act all such rules as are necessary to implement the provisions of this 11 Chapter.

Abstract: Establishes within the Dept. of Children and Family Services a continuum of care program for biological parents of unborn children and biological or adoptive parents of child under the age of two.

<u>Proposed law</u> creates within the Dept. of Children and Family Services (DCFS) a continuum of care program for certain pregnant women and parents. Provides that the purpose of the program is to facilitate the operation of a statewide telecare support network that provides community outreach, consultations, and care coordination for women who are challenged with unexpected pregnancies.

<u>Proposed law</u> provides that the continuum of care program shall be designed to accomplish all of the following goals:

- (1) Encourage healthy childbirth.
- (2) Support childbirth as an alternative to abortion.
- (3) Promote family formation.
- (4) Assist parents in establishing successful parenting techniques.
- (5) Increase the economic self-sufficiency of families.

<u>Proposed law</u> provides that the continuum of care program shall encompass the existing TANF initiative known as "Alternatives to Abortion" along with a statewide telecare support network. Requires that DCFS provide in rule for the functions and administration of the telecare support network.

<u>Proposed law</u> requires that DCFS finance the continuum of care program with TANF funds and any other monies appropriated to it by the legislature for operation of the program.

<u>Proposed law</u> provides that the continuum of care program shall provide direct services, supports, social services case management, and referrals to biological parents of unborn children and biological or adoptive parents of children under the age of two years. Provides that the components of the program shall include, without limitation, all of the following:

- (1) Outreach to at-risk populations eligible for the program.
- (2) Utilization of registered nurses to assess and evaluate needs related to pregnancy or parenting and to provide medically accurate, pregnancy-related medical information to program participants.
- (3) Utilization of social workers or other licensed individuals with equivalent experience to perform the following functions:
 - (a) Development of a care plan, resources, and supports for program participants to address identified needs.
 - (b) Referrals to appropriate local resources including, without limitation, state and federal benefits programs and local charitable organizations.
 - (c) Assistance in applying for state and federal benefits programs.
 - (d) Assistance in accomplishing elements of the care plan.

<u>Proposed law</u> stipulates that in order to be eligible to receive services through the continuum of care program, an individual shall, at the time of initial contact with the program, meet all of the following requirements:

- (1) Is a resident of this state.
- (2) Is a biological parent of an unborn child or a biological or adoptive parent of a child under the age of two years.

<u>Proposed law</u> provides that any program participant who terminates a pregnancy shall be eligible to continue receiving services through the continuum of care program for a period of six months from the date of the pregnancy termination.

<u>Proposed law</u> requires that on or before Dec. 1, 2022, and annually thereafter, DCFS shall submit to the legislative committees on health and welfare a report on the status and operation of the continuum of care program and provides requirements for the content of such reports.
