A RESOLUTION

To express the condolences of the House of Representatives on the death of Kevin Millican and commend him for his public service.

WHEREAS, it is with immense sadness and profound regret that the House of Representatives has learned of the tragic and untimely passing of Jefferson Davis Parish District Attorney, Kevin Millican; and

WHEREAS, Kevin was a native and lifelong resident of Jennings, Louisiana; he graduated from Jennings High School where he was a standout baseball player; during his high school career he set several school hitting records that still stand; and

WHEREAS, after graduating, Kevin attended Southeastern State University; he continued his baseball career in college and earned an all-conference selection; he also received a bachelor's degree in business marketing; and

WHEREAS, Kevin was drafted in the 13th round of the 1994 Major League Baseball Draft by the Texas Rangers Baseball Club; he started his professional baseball career with Hudson Valley in the Penn/State League, and the following year, he was promoted to High A Ball to play for the Charleston River Dogs; and

WHEREAS, Kevin returned to school after his professional baseball career, and in 1999, he received a juris doctorate degree from Southern University Law Center; he practiced law privately for twenty-one years and served as the city attorney and prosecutor for the city of Jennings from 2000 until his passing; and

WHEREAS, Mr. Millican was sworn into office as the Jefferson Davis Parish District Attorney in January 2021; prior to being elected, he served the parish for more than twenty years as an assistant district attorney; and

WHEREAS, Mr. Millican was a member of the Jennings Chamber of Commerce, the Louisiana Bar Association, and the Louisiana District Attorney's Association, and he served as the president of the Jefferson Davis Bar Association; and

WHEREAS, in addition to his professional engagements, Mr. Millican was a member of Our Lady Help of Christians Church where he served on the parish council; he was also on the school board of Our Lady Immaculate Catholic School; and

WHEREAS, Kevin Millican leaves to cherish his memory his loving and devoted wife of twenty-five years, Kristy Anderson Millican; daughters, Abbie Lauren Millican and Grace Anne Millican; son, William Joseph Millican; mother, Jacquelyn Suarez Millican; brother, F. Jefferson Millican, Jr., and his wife Lisa; sister, Hannah Millican Plummer; father- and mother-in-law, Steve and Linda Anderson; brother- and sister-in-law, Lee and Amy Anderson; and nieces and nephews, Sarah Millican, Ford Millican, Luke Millican, and Payton Anderson; he will be deeply missed.

THEREFORE, BE IT RESOLVED that the House of Representatives of the Legislature of Louisiana does hereby express heartfelt condolences on the death of Kevin Millican; does hereby commend him for his public service; and does hereby extend sincerest wishes that his family find comfort during this extremely difficult time.
