The fee shall be reported and paid by the licensed production facility or 24 permitted contractor that sells therapeutic marijuana to marijuana pharmacies. The 25 fee that shall be collected by the Department of Revenue and shall be subject to the provisions of Chapter 18 of Subtitle II of Title 47 of the Louisiana Revised Statutes 26 27 of 1950 as amended. Notwithstanding the provisions of Subparagraph (b) of this 28 Paragraph, the Department of Revenue shall transfer monthly to the state treasury for 29 deposit into the Community and Family Support System Fund, as established in R.S. 30 28:826, the amount of revenues collected in accordance with this Item. An amount shall be allocated to the department, pursuant to legislative appropriation, for 31 32 regulatory, administrative, investigative, enforcement, legal, and other such expenses 33 as may be necessary to carry out the provisions of this Chapter and for activities 34 associated with the enforcement of law and regulations governing the therapeutic 35 marijuana program."
