In addition to all other fees or costs now or hereafter provided by law, the 11 clerk of court of the Nineteenth Judicial District shall collect from every person 12 filing any action, suit, or motion and rule to show cause on the docket of the Family 13 Court of East Baton Rouge Parish and who is not otherwise exempted by law from 14 the payment of court costs, a sum to be determined by the judges of said court, sitting 15 en banc, which sum shall not exceed twenty-five thirty-five dollars, subject, 16 however, to the provisions of Louisiana Code of Civil Procedure, Article 5181 et 17 seq.; and in all criminal nonsupport cases over which the Family Court of East Baton Rouge Parish has jurisdiction, including contempt proceedings provided for by 18 19 Children's Code Article 1353, there shall be taxed as costs against every defendant

who is convicted after trial or after plea of guilty or who forfeits his bond, a sum

Abstract: Increases the minimum fee collected by the clerk of the 19th Judicial District Court for actions on the docket of the Family Court of East Baton Rouge Parish <u>from</u> \$25 <u>to</u> \$35.

<u>Present law</u> requires the clerk of court for the 19th JDC to collect a filing fee not to exceed \$25 from every person filing any action, suit, or motion and rule to show cause on the docket of the Family Court of East Baton Rouge Parish.

Proposed law increases the filing fee from \$25 to \$35.

<u>Proposed law</u> provides that the increase in court costs or fees shall become effective upon approval by the Judicial Council.
