# 14(5) "In-person, in-class, instructor-supervised" means students15physically attend class or clinical session at the approved school location16with their instructor and other classmates.

# 17 (5)(6) "Lapsed license" means a board-issued license which has not 18 been renewed for a period of more than two years and the holder of the 19 license has not taken inactive status.

20 (6)(7) "Licensee" means any person or business that has a 21 professional or establishment license issued by the board.

22 (7)(8) "Massage establishment" means any place of business that 23 offers the practice of massage therapy and where the practice of massage therapy is conducted on the premises of the business. A place of business 24 25 includes any office, clinic, facility, or other location where a person or 26 persons engage in the practice of massage therapy. The residence of a 27 therapist or an out call location which is not owned, rented, or leased by a 28 massage therapist or massage establishment shall not be considered a 29 massage establishment, unless the location is advertised as the therapist's or 30 establishment's place of business. The term "massage establishment" shall 31 not include physician offices, physical therapy facilities, chiropractic offices, 32 or athletic training facilities, whether or not they employ, contract with, or 33 rent to massage therapists, or institutions of secondary or higher education 34 when massage therapy is practiced in connection with employment related 35 to athletic teams.

- 36 (8)(9) "Massage therapist" means a person who engages in the
   37 practice of massage therapy for compensation.
- 38 (9)(10) "Person" means an individual, corporation, association, or
   39 other legal entity.

1 (10)(11) "Practice of massage therapy" means the manipulation of 2 soft tissue for the purpose of maintaining good health and establishing and 3 maintaining good physical condition. The practice of massage therapy shall 4 include advertising or offering to engage in the practice of massage therapy 5 and holding oneself out or designating oneself to the public as a massage therapist or massage establishment. The practice of massage therapy shall 6 7 include effleurage (stroking), petrissage (kneading), tapotement (percussion), 8 compression, vibration, friction (active/passive range of motion), stretching 9 activities as they pertain to massage therapy, Shiatsu, acupressure, 10 reflexology, trigger point massage, and Swedish massage either by hand, 11 forearm, elbow, foot, or with mechanical appliances for the purpose of body massage. Massage therapy may include the use of lubricants such as salts, 12 powders, liquids, creams with the exception of prescriptive or medicinal 13 14 creams, heat lamps, hot and cold stones, whirlpool, hot and cold packs, salt 15 glow, body wraps, steam cabinet baths, and, with appropriate training, the use of non-prescriptive, off-the-shelf commercially available 16 17 electromechanical devices for which they are trained which mimic or enhance the actions possible by the hands. It shall not include ultrasound, 18 19 laser therapy, microwave, colonic therapy, injection therapy, manipulation 20 of the joints, the use of electrical muscle stimulation, or transcutaneous electrical nerve stimulation except microcurrent. Equivalent terms for 21 massage therapy are massage, therapeutic massage, massage technology, 22 23 body work, or any derivation of those terms. As used in this Chapter, the 24 terms "therapy" and "therapeutic" shall not include diagnosis, the treatment 25 of illness or disease, or any service or procedure for which a license to practice medicine, chiropractic, physical therapy, or podiatry is required by 26 27 law.

- (11)(12) "Professional Massage Therapy Association" means a
   statewide organization or statewide chapter of an organization which meets
   all of the following criteria:
- 31 (a) Either directly, or through the parent organization, qualifies as a
  32 tax exempt nonprofit organization under 26 U.S.C. 501(c)(6).
- 33 (b) Within Louisiana, offers a voting membership to licensed massage
  34 therapists who practice or reside in Louisiana and who maintain their voting
  35 membership in good standing.
- (c) Within Louisiana, is administered by a governing body composed
   of officers democratically elected by the organization's voting membership
   within Louisiana.

# 39(13) "Real-time synchronous distance learning" means students40attend class session virtually at the same time as the instructor and other41class mates.

### 42 (12)(14) "Writing" shall be a written communication transmitted 43 either by United States mail or by electronic means such as e-mail email.
