MUSEUMS/STATE MUSEUM: Establishes the Dew Drop-America's Rock and Roll Museum within the Department of Culture, Recreation and Tourism

1	AN ACT	
2	To enact Chapter 5-G of Title 25 of the Louisiana Revised Statues of 1950, to be comprised	
3	of R.S. 25:380.41 through 45, and R.S. 36:209(C)(5), relative to museums; to	
4	establish the Dew Drop-America's Rock and Roll Museum as a facility within	
5	Orleans Parish; to place the museum under the jurisdiction of the Department of	
6	Culture, Recreation and Tourism; to provide for an effective date; and to provide fo	
7	related matters.	
8	Be it enacted by the Legislature of Louisiana:	
9	Section 1. Chapter 5-G of Title 25 of the Louisiana Revised Statues of 1950,	
10	comprised of R.S. 25:380.41 through 45, is hereby enacted to read as follows:	
11	CHAPTER 5-G. DEW DROP-AMERICA'S ROCK AND ROLL MUSEUM	
12	§380.41. Establishment and location: purpose and use	
13	A. The Dew Drop-America's Rock and Roll Museum, referred to in this	
14	Chapter as the "museum", is established as a facility in the parish of Orleans, under	
15	the overall jurisdiction of the Department of Culture, Recreation and Tourism,	
16	referred to in this Chapter as the department, as more specifically provided in this	
17	Chapter.	
18	B. The museum shall be a historical, cultural, scientific, and technological	
19	educational institution whose primary purpose shall be to research, collect, preserve,	

1	and present, as an educational resource, the music, recordings, pictures, documents,		
2	artifacts, objects of art, and the like that reflect the social, cultural, and economic		
3	history of rock and roll music in the state of Louisiana and in the Orleans Parish area		
4	in particular.		
5	§380.42. Governing board		
6	A. The board of directors of the museum, referred to in this Chapter as the		
7	"board", is hereby created within the department. The board shall have and exercise		
8	all powers, duties, functions, and responsibilities authorized for it by law.		
9	B. The board is comprised as follows:		
10	(1) The lieutenant governor shall appoint one member.		
11	(2) The LaSalle Cultural Corridor Commission shall appoint one member.		
12	(3) The mayor of New Orleans shall appoint one member.		
13	(4) The New Orleans city council shall appoint one member.		
14	(5) The board of trustees of the Recording Academy shall appoint one		
15	member.		
16	(6) The members of the board appointed pursuant to Paragraphs (1) through		
17	(5) of this Subsection shall appoint two members who represent cultural institutions		
18	or culture-sector industries in Louisiana.		
19	$\underline{C.(1)}$ Members of the board shall serve four-year terms after initial terms as		
20	provided in this Paragraph. Two members shall serve an initial term of one year, one		
21	shall serve an initial term of two years, one shall serve an initial term of three years,		
22	and one shall serve an initial term of four years, as determined by lot at the first		
23	meeting of the board.		
24	(2) Members shall serve without compensation.		
25	(3) A majority of the board shall constitute a quorum for the transaction of		
26	official business. All official actions of the board shall require the affirmative vote		
27	of a majority of the members present and voting.		
28	D. The board shall:		
29	(1) Meet at least three times a year at the call of the board chairman.		

1	(2) Adopt bylaws, which shall include provisions for the following:
2	(a) The election and responsibilities of the officers of the board, including
3	a chairman and vice chairman, who shall serve terms of two years.
4	(b) The selection and responsibilities of advisors to the board. The board
5	may appoint not more than five advisors who shall serve without compensation.
6	(c) The appointment, duties, and functions of standing and special
7	committees of the board, including the appointment of nonboard members to such
8	committees and their functions.
9	(3) Advise the lieutenant on all matters relating to the operations of the
10	museum.
11	(4) Establish and use an identifying seal pertaining to museum business.
12	(5) Perform such other functions as are otherwise provided by this Chapter.
13	E. The board may individually, or in cooperation with any nonprofit
14	corporation established to support the museum, seek funds from any source, public
15	or private, to support programs of the museum and expend such funds for such
16	purpose.
17	§380.43. Operating funds; appropriations by the legislature
18	The department shall include in its annual budget request, required by R.S.
19	39:32, a request for funds necessary for support of the museum. The governor shall
20	include in the executive budget submitted to the legislature sufficient funding for the
21	support of operations and maintenance of the museum and its exhibits.
22	§380.44. Donations and loans; disposition of property
23	A. The department or any nonprofit corporation formed to support the
24	museum and its activities, jointly or separately, may solicit and accept funds,
25	governmental grants, donations, and contributions of lands, buildings, monies,
26	artifacts, relics, audio and video recordings, motion picture films, works of art, or
27	other property on behalf of and as additions to the museum either in the form of
28	loans or in the form of donations inter vivos or mortis causa, and the department may
29	acquire them by purchase, lease, or otherwise, subject to the terms, conditions, or

1	limitations contained in the instrument by which such property is acquired.
2	However, the museum, through the department or a nonprofit formed to support the
3	programs and activities of the museum, may enter into any and all contracts with any
4	person, lender, or donor that it deems fit, proper, and necessary to accept and receive
5	such lands, buildings, monies, artifacts, relics, audio and video recordings, motion
6	picture films, works of art, or other property on behalf of, as additions to, or for the
7	benefit of the museum. The museum may serve as the beneficiary of any public or
8	private trust or insurance policy created for such purpose, pursuant to the provision
9	<u>of R.S. 9:2341 et seq.</u>
10	B. The board is granted the authority of deaccession with respect to any
11	collection of the museum, and for such purpose is exempted from laws relative to the
12	sale or disposal of surplus property. The board shall establish policies and
13	procedures necessary to carry out this authority in an orderly manner.
14	$\underline{C.(1)}$ Any property that has been deposited with the museum by loan or
15	otherwise, that has been held by the museum for more than ten years, and that no
16	person has made claim shall be deemed to be abandoned and, notwithstanding the
17	provisions of Chapter 1 of Title XII of Book III of the Louisiana Civil Code, shall
18	escheat to and become the property of the museum, if the board complies with
19	Paragraph (2) of this Subsection.
20	(2)(a) At least once each week for two consecutive weeks, the board shall
21	cause to be published in at least one newspaper of general circulation in the parish
22	of Orleans a notice and listing of the property.
23	(b) The notice shall contain:
24	(i) The name and last known address, if any, of the last known owner or
25	depositor of the property.
26	(ii) A description of the property.
27	(iii) A statement that if proof of claim is not presented by the claimant to the
28	board and if the claimant's right to receive such property is not established to the
29	satisfaction of the board within sixty-five days from the date of the second published

1	notice, the property will be deemed to be abandoned and shall become the property		
2	of the museum.		
3	(3) If no valid claim has been made to the property within sixty-five days		
4	from the date of the second published notice, title to the property shall escheat to and		
5	vest in the museum free from all claims.		
6	§380.45. Use of collections and property		
7	Any collection or other property of the museum may, subject to approval of		
8	the board, be lent in part. The board shall ensure proper safeguards for its		
9	maintenance and return and shall ensure that proper records are kept. The collection		
10	or other property shall be available for use in educational projects, subject to the		
11	approval of the board.		
12	Section 2. R.S. $36:209(C)(5)$ is hereby enacted to read as follows:		
13	§209. Transfer of boards, commissions, departments, and agencies to Department		
14	of Culture, Recreation and Tourism		
15	* * *		
16	C. The following agencies are hereby placed within the Department of		
17	Culture, Recreation and Tourism and shall exercise and perform their powers, duties,		
18	functions, and responsibilities in accordance with the provisions of R.S. 36:801.1:

20	(5) Board of directors of the Dew Drop-America's Rock and Roll Museum		
21	<u>(R.S. 25:380.41 et seq.).</u>

23	Section 2. This Act shall become effective upon signature by the governor or, if not		
24	signed by the governor, upon expiration of the time for bills to become law without signature		
25	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If		
26	vetoed by the governor and subsequently approved by the legislature, this Act shall become		
27	effective on the day following such approval.

Abstract: Establishes the Dew Drop-America's Rock and Roll Museum as a facility in Orleans Parish.

<u>Proposed law</u> establishes the Dew Drop-America's Rock and Roll Museum as a facility in the parish of Orleans. Provides that the museum shall research, collect, preserve, and present, as an educational resource, the music, recordings, pictures, documents, artifacts, objects of art, and the like that reflect the social, cultural, and economic history of rock and roll music in the state and in the Orleans Parish area in particular.

<u>Proposed law</u> creates the board of directors of the museum to govern the museum. Provides that the board is comprised as follows:

- (1) The lieutenant governor shall appoint one member.
- (2) The LaSalle Cultural Corridor Commission shall appoint one member.
- (3) The mayor of New Orleans shall appoint one member.
- (4) The New Orleans city council shall appoint one member.
- (5) The board of trustees of the Recording Academy shall appoint one member.
- (6) The members of the board appointed as provided above shall appoint two members who represent cultural institutions or culture-sector industries in La.

<u>Proposed law</u> provides that members serve four-year staggered terms without compensation.

<u>Proposed law</u> requires the board to:

- (1) Meet at least three times a year at the call of the board chairman.
- (2) Adopt bylaws.
- (3) Advise the lieutenant on all matters relating to the operations of the museum.
- (4) Establish and use an identifying seal pertaining to museum business.

<u>Proposed law</u> authorizes the board, individually or in cooperation with any nonprofit corporation established to support the museum, to seek funds from any source to support programs of the museum and expend such funds for such purpose.

<u>Proposed law</u> requires Dept. of Culture, Recreation and Tourism to include in its annual budget request a request for funds necessary for support of the museum. Further requires the governor to include in the executive budget sufficient funding for the support of operations and maintenance of the museum and its exhibits.

<u>Proposed law</u> authorizes the department and any nonprofit corporation formed to support the museum, jointly or separately, to solicit and accept funds and other property for the museum either as loans or donations and provides with respect thereto. Authorizes the museum to

serve as the beneficiary of any public or private trust or insurance policy created for such purpose. Grants the board authority of deaccession with respect to any collection of the museum and in case of such deaccessions exempts the board from <u>present law</u> relative to sale or disposal of surplus property. Requires board policies and procedures to carry out such authority.

<u>Proposed law</u> provides relative to unclaimed property loaned to or otherwise left with the museum. Provides that such property shall become property of the museum after 10 years and after notice according to specified procedures. Provides relative to loans of museum property. Provides that museum collections shall be available for use in educational projects subject to board approval.

Effective upon signature of governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by House

- The Committee Amendments Proposed by <u>House Committee on Municipal, Parochial</u> <u>and Cultural Affairs</u> to the <u>original</u> bill:
- 1. Provide that members serve four-year staggered terms rather than terms concurrent with the lt. governor.
- 2. Change the relationship between the museum's board and the Dept. of Culture, Recreation and Tourism.
- 3. Provide for an emergency effective date.
