2 To enact R.S. 39:34(F) and 54(E), relative to the expenditure of state funds; to limit 3 recommended appropriations from state general fund revenue-direct in the executive 4 budget; to limit appropriations from state general fund revenue-direct by the 5 legislature; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: Section 1. Abstract: Limits appropriations from state general fund revenue-direct to 98% of the official forecast.

<u>Present law</u> requires that recommendations for appropriations in the executive budget for the ensuing fiscal year from the state general fund and dedicated funds not exceed the official forecast of the Revenue Estimating Conference (REC).

<u>Proposed law</u> retains <u>present law</u> and additionally requires that, beginning with the executive budget for FY 2023-2024, recommendations for appropriations from state general fund revenue-direct not exceed 98% of the official REC forecast for state general fund revenue-direct.

<u>Present law</u> requires that appropriations by the legislature from the state general fund and dedicated funds not exceed the official forecast in effect at the time the appropriations are made.

<u>Proposed law</u> retains <u>present law</u> and additionally requires that, beginning with FY 2023-2024, appropriations from state general fund revenue-direct not exceed 98% of the official REC forecast for state general fund revenue-direct.

<u>Proposed law</u> defines "state general fund revenue-direct" as total taxes, licenses, and fees and any additional funds incorporated into the forecast less dedications as recognized by the REC.
