1 AMENDMENT NO. 1

- 2 On page 1, line 2, change "R.S. 22:47(18)" to "R.S. 22:47(14) and (18)"
- 3 AMENDMENT NO. 2
- 4 On page 1, line 5, change "R.S. 22:47(18) is" to "R.S. 22:47(14) and (18) are"
- 5 AMENDMENT NO. 3

6 On page 1, line 3, delete "insurance;" and insert in lieu thereof "insurance in excess of that 7 provided by certain insurers; to provide for excess share insurance; to reclassify certain

- 8 forms of surety insurance; to provide for licensure; to provide for effectiveness;"
- 9 AMENDMENT NO. 4
- 10 On page 1, between lines 7 and 8 insert the following:
- "* 11 (14) Miscellaneous. Any other kind of loss, damage, or liability properly the 12 13 subject of insurance and not within any other kind or kinds of insurance as defined 14 in this Section, if such insurance is not contrary to law or public policy. However, 15 no person or insurer may offer primary deposit insurance, except the Federal Deposit 16 Insurance Corporation or National Credit Union Administration, or any similar 17 insurance corporation hereinafter created by the Congress of the United States or the 18 legislature of any state for deposits in banks, savings and loan associations, savings 19 banks, credit unions, finance operations, or similar institutions. Notwithstanding the 20 provisions of this Paragraph, an insurance corporation or other similar person may 21 be licensed to offer excess share insurance to provide coverage for an amount established by policy above those amounts insured by the National Credit Union 22 23 Administration and if licensed, may offer such excess share insurance to any credit union in this state. Notwithstanding the provisions of this Paragraph, an insurance 24 25 corporation or other similar person may be licensed to offer excess deposit insurance to provide coverage for an amount established by policy above those amounts 26 insured by the Federal Deposit Insurance Corporation and if licensed, may offer such 27 28 excess deposit insurance to any bank, savings and loan association, or savings bank 29 operating in this state."
- 30 AMENDMENT NO. 5
- 31 On page 1, after line 18, add the following:

32 "Section 2. This Act shall become effective upon signature by the governor or, if not 33 signed by the governor, upon expiration of the time for bills to become law without signature 34 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 35 vetoed by the governor and subsequently approved by the legislature, this Act shall become 36 effective on the day following such approval."
