TAX/HOTEL OCCUPANCY: Authorizes the town of Henderson to levy a hotel occupancy tax

AN ACT

2 To enact R.S. 47:338.223, relative to the town of Henderson; to authorize the town to levy 3 a hotel occupancy tax; to provide for the use of tax revenues; and to provide for 4 related matters. 5 Notice of intention to introduce this Act has been published as provided by Article III, Section 13 of the Constitution of 6 7 Louisiana. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. R.S. 47:338.223 is hereby enacted to read as follows: 10 §338.223. Town of Henderson; hotel occupancy tax; authorization 11 A.(1) In addition to any other tax levied and collected, the governing 12 authority of the town of Henderson may levy and collect a tax upon the paid 13 occupancy of hotel rooms located within the town. The hotel occupancy tax shall not exceed four percent of the rent or fee charged for such occupancy. 14 15 (2) The word "hotel" as used in this Section shall mean and include any 16 establishment, public or private, including an establishment at a structure used as a 17 residence, engaged in the business of furnishing or providing rooms or overnight camping facilities intended or designed for dwelling, lodging, or sleeping purposes 18 19 to transient guests where such establishment consists of two or more guest rooms or 20 two or more overnight camping facilities, or if the establishment has both guest

1	rooms and camping facilities, at least one of each, and does not encompass any
2	hospital, convalescent or nursing home or sanitarium, or any hotel-like facility
3	operated by or in connection with a hospital or medical clinic providing rooms

5	(3) The person who exercises or is entitled to occupancy of the hotel room
6	shall pay the hotel occupancy tax at the time the rent or fee for occupancy is paid.
7	"Person" as used in this Paragraph shall have the same definition as that contained
8	<u>in R.S. 47:301(8).</u>
9	B. The governing authority shall impose the hotel occupancy tax by
10	ordinance or resolution. The governing authority may adopt such ordinance or
11	resolution only after a proposition authorizing the levy of the tax has been approved
12	by a majority of the electors of the town voting at an election held for that purpose
13	in accordance with the Louisiana Election Code. The governing authority may
14	provide in the ordinance or resolution necessary and appropriate rules and
15	regulations for the imposition, collection, and enforcement of the hotel occupancy
16	<u>tax.</u>
17	C. The governing authority may enter into a contract with any public entity
18	authorized to collect sales or use taxes, under such terms and conditions as it may
19	deem appropriate including payment of a reasonable collection fee, for the collection
20	of the hotel occupancy tax authorized by this Section. The hotel occupancy tax shall
21	be in addition to all taxes levied upon the occupancy of hotel rooms located within
22	the town.
23	D. Except as provided in Subsection C of this Section, the governing
24	authority shall use the proceeds of the tax to fund economic development, tourism
25	promotion, and related infrastructure within the town.

**Abstract:** Authorizes the town of Henderson, in St. Martin Parish, to levy and collect a hotel tax at a rate not to exceed 4%, subject to voter approval.

<u>Proposed law</u> authorizes the governing authority of Henderson (St. Martin Parish), subject to voter approval, to levy and collect a hotel occupancy tax. Provides that such tax shall not exceed 4% of the rent or fee charged for such occupancy.

<u>Proposed law</u> requires that the tax be paid by the person who exercises or is entitled to occupancy of the hotel room at the time the rent or fee for occupancy is paid. Authorizes the governing authority to contract with any public entity authorized to collect sales or use taxes for the collection of the hotel occupancy tax. Requires that the proceeds of the tax be used to fund economic development, tourism promotion, and related infrastructure within the town.

## Summary of Amendments Adopted by House

1. Specify that the definition of "hotel" includes establishments consisting of two or more overnight camping facilities.

1. Specify that the definition of "hotel" includes an establishment at a residence.
