TRANSPORTATION: Creates a task force to study and make recommendations on protective measures for improving the safety of ridesharing services

1	A RESOLUTION		
2	To create a task force to study and make recommendations on protective measures for		
3	improving the safety of ridesharing services.		
4	WHEREAS, the regulation of transportation network companies throughout the state		
5	was enacted by Act No. 286 of the 2019 Regular Session of the Legislature; and		
6	WHEREAS, transportation network companies are also known as ridesharing		
7	companies and include services such as Uber and Lyft; and		
8	WHEREAS, ridesharing services have fundamentally changed the nature of		
9	transportation; and		
10	WHEREAS, millions of people utilize ridesharing services for the convenience and		
11	reliability of their quick response for transportation services; and		
12	WHEREAS, safety has become a central issue surrounding ridesharing services		
13	despite the ever-growing popularity of ridesharing companies; and		
14	WHEREAS, according to Uber's 2019 safety report there were thousands of		
15	unsuspecting rideshare passengers and drivers sexually assaulted, fifty-eight fatalities, and		
16	nine fatal physical assaults reported out of one billion three hundred million total rides in the		
17	United States in 2018; and		
18	WHEREAS, ridesharing services are more common at "high crime times" such as		
19	weekend nights when riders are more likely to be intoxicated; and		
20	WHEREAS, there is always a risk when taking a car ride with a stranger and		
21	ridesharing services have shown no signs of slowing down; and		

1	WHEREAS, legislative bodies across the nation are exploring options for improving		
2	the safety of ridesharing services; and		
3	WHEREAS, in an effort to protect and safeguard rideshare passengers and drivers		
4	against harm it is vital to study and make recommendations on protective measures for		
5	improving the safety of ridesharing services.		
6	THEREFORE, BE IT RESOLVED that the House of Representatives of the		
7	Legislature of Louisiana does hereby create a task force to study and make recommendations		
8	on protective measures for improving the safety of ridesharing services.		
9	BE IT	FURTHER RESOLVED that the recommendations of the task force shall	
10	identify safety measures that aid in decreasing crime and violence and, at a minimum, shall		
11	include the following considerations:		
12	(1)	The potential safety risks.	
13	(2)	The best way to resolve ridesharing services safety issues.	
14	(3)	The safety implications of ridesharing services.	
15	(4)	The possibility of requiring the installation of a detachable security camera	
16		system in rideshare vehicles.	
17	(5)	The possibility of ongoing ridesharing safety monitoring.	
18	BE IT FURTHER RESOLVED that the task force shall consist of seven members		
19	and be composed of the following:		
20	(1)	A representative of the Louisiana Chiefs of Police Association, appointed by	
21		the president of the association.	
22	(2)	A representative of the Louisiana Sheriffs' Association, appointed by the	
23		president of the association.	
24	(3)	The superintendent of Louisiana State Police or his designee.	
25	(4)	The secretary of the Department of Transportation and Development or his	
26		designee.	
27	(5)	A representative of the House of Representatives appointed by the speaker	
28		of the House of Representatives.	

- 1 (6) Two representatives of the Transportation Network Companies industry 2 appointed by the secretary of the Department of Transportation and 3 Development.
- 4 BE IT FURTHER RESOLVED that the task force shall submit a written report to the
- 5 House Committee on Transportation, Highways and Public Works detailing its findings and
- 6 recommendations prior to March 1, 2023.
- 7 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 8 secretary of the Department of Transportation and Development, the president of the
- 9 Louisiana Chiefs of Police Association, the president of the Louisiana Sheriffs' Association,
- 10 and the superintendent of Louisiana State Police.

Creates a task force comprised of seven members to study and make recommendations on protective measures for improving ridesharing services safety. Requires the task force to submit a written report of its findings to the House Transportation committee prior to March 1, 2023.
