Amendments proposed by Senator Morris to Engrossed Senate Bill No. 143 by Senator Morris

1 AMENDMENT NO. 1

2 On page 2, line 2, after "(3)" insert "(a)"

3 AMENDMENT NO. 2

4 On page 2, line 3, after "Forces" delete "with no pending disciplinary proceedings"

5 AMENDMENT NO. 3

6 On page 2, at the beginning of line 4, delete "reserve or active duty"

7 AMENDMENT NO. 4

8 On page 2, line 5, after "Guard" delete "with no pending disciplinary proceedings"

9 AMENDMENT NO. 5

10 On page 2, between lines 8 and 9, insert the following:

11 **"(b) At all times that a person is in possession of a concealed handgun**  
12 **pursuant to R.S. 40:1379.3(B)(2), that person shall have on his person proof that**  
13 **he meets the qualifications of Subparagraph (a) of this Paragraph demonstrated**  
14 **by one of the following:**

15 **(i) A valid military identification card.**

16 **(ii) A valid driver's license issued by the state of Louisiana displaying the**  
17 **word "Veteran" pursuant to R.S. 32:412(K).**

18 **(iii) A valid special identification card issued by the state of Louisiana**  
19 **displaying the word "Veteran" pursuant to R.S. 40:1321(K).**

20 **(iv) For a member released from service who does not qualify to have the**  
21 **word "Veteran" displayed on a state issued driver's license or special**  
22 **identification card, a Department of Defense Form 214 (DD-214) indicating the**  
23 **character of service as "Honorable" or "Under Honorable Conditions**  
24 **(General)" and a valid driver's license or special identification card issued by**  
25 **the state of Louisiana."**

26 AMENDMENT NO. 6

27 On page 2, line 15, after "(2)" insert "(a)"

28 AMENDMENT NO. 7

29 On page 2, between lines 22 and 23, insert the following:

30 **"(b) Any person carrying a concealed firearm pursuant to this**  
31 **Paragraph shall be deemed to have certified that he meets all of the conditions**  
32 **required in R.S. 14:95(M)."**

33 AMENDMENT NO. 8

34 On page 4, between lines 8 and 9, insert the following:

35 **"E. State police shall post prominently on its website all conditions**  
36 **required to be met to authorize the carrying of a concealed handgun without a**

1 valid concealed handgun permit pursuant to R.S. 14:95(M) and R.S.  
2 40:1379.3(B)(2)."

3 AMENDMENT NO. 9

4 On page 4, at the beginning of line 9, change "E." to "F."
