#### HOUSE BILL NO. 92

#### BY REPRESENTATIVE ECHOLS

1	AN ACT
2	To enact R.S. 47:463.214, relative to motor vehicle special prestige license plates; to provide
3	for the "Laissez les ARTS Rouler" special prestige license plate; to provide for the
4	creation, issuance, design, implementation, fees, distribution, and rule promulgation
5	applicable to such license plate; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 47:463.214 is hereby enacted to read as follows:
8	§463.214. Special prestige license plate; "Laissez les ARTS Rouler"
9	A. The secretary of the Department of Public Safety and Corrections shall
10	establish a special prestige motor vehicle license plate to be known as the "Laissez
11	les ARTS Rouler" plate, provided there is a minimum of one thousand applicants for
12	such plate. The plate shall be restricted to use on passenger cars, pickup trucks,
13	motorcycles, recreational vehicles, and vans.
14	B. The secretary shall work in conjunction with the president of Northeast
15	Louisiana Arts Council and the chair of the Louisiana Partnership for the Arts to
16	select the color and design of the plate, provided it is in compliance with R.S.
17	47:463(A)(3). The design shall include the words "Laissez les ARTS Rouler".
18	C. The special prestige license plate shall be issued, upon application, to any
19	citizen of Louisiana in the same manner as any other motor vehicle license plate.
20	D. The department shall collect an annual royalty fee of twenty-five dollars
21	that shall be disbursed in accordance with Subsection E of this Section. This royalty
22	fee shall be in addition to the standard motor vehicle license tax imposed by Article

### **ENROLLED**

1	VII, Section 5 of the Constitution of Louisiana, and a handling fee of three dollars
2	and fifty cents for each plate to be retained by the department to offset a portion of
3	administrative costs.
4	E. The annual royalty fee shall be collected by the department and forwarded
5	to the Louisiana Partnership for the Arts. The monies received from the royalty fees
6	shall be used for the Louisiana Partnership for the Arts educational and engagement
7	efforts, and other related programs on behalf of public support for the arts, in the
8	state of Louisiana.
9	F. The secretary shall promulgate rules and regulations as are necessary to
10	implement the provisions of this Section.
11	Section 2. The Department of Public Safety and Corrections, office of motor
12	vehicles, is hereby directed to create the special prestige license plate when the applicable
13	statutory provisions are met and its system is updated to accommodate the creation of new
14	plates.
